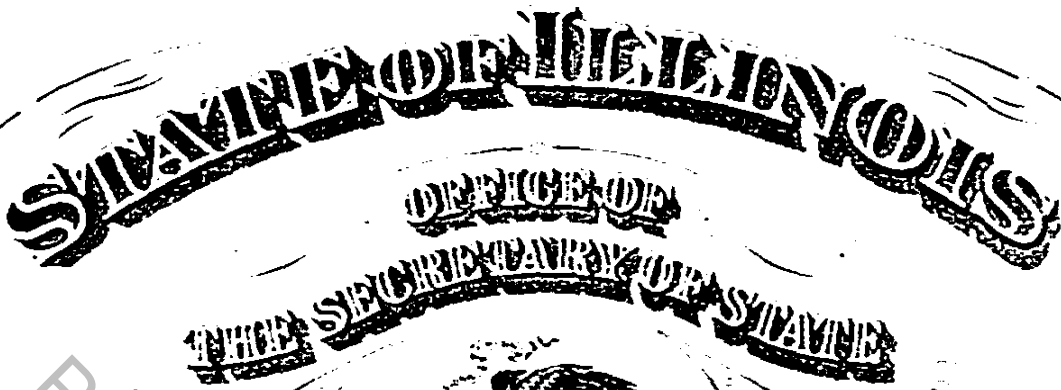

THIS INDENTURE WITNESSETH, That the undersigned as grantors, of Hickory Hills County of Cook
 and State of Illinois for and in consideration of the sum of One Dollar and other good and valuable considerations, in hand paid,
 convey and warrant to Archer National Bank of Chicago
 County of Cook and State of Illinois the following described Real Estate, with all improve-
 ments thereon, situated in the County of COOK in the State of Illinois to wit:

Lot 4 in Fitzpatrick's Subdivision of part of the West half of the North West
1/4 of Section 1, Township 37 North, Range 12 East of the Third Principal
Meridian in Cook County, Illinois.

hereby releasing and waiving all rights under and by virtue of the homestead exemption laws of the State of Illinois

GRANTORS AGREE to pay all taxes and assessments upon said property when due, to keep the buildings thereon insured to their full insurable value, to pay all prior incumbrances and the interest thereon and to keep the property tenable and in good repair and free of liens. In the event of failure of Grantors to comply with any of the above covenants, then grantee is authorized to attend to the same and pay the bills therefor, which shall with 5% interest thereon, become due immediately, without demand. On default in any payments hereunder, grantee may declare the whole indebtedness due and proceed accordingly.

AS FURTHER SECURITY grantors hereby assign, transfer and set over to grantee all the rents, issues and profits of said premises, from and after this date, and authorize him to sue for, collect and receipt for the same, to serve all necessary notices and demands, to bring forcible detainer proceedings to recover possession thereof, to rent the said premises as he may deem proper and to apply the money so arising to the payment of this indebtedness, or to any advancements made as aforesaid, and it shall not be the duty of grantee to inquire into the validity of any such taxes, assessments, liens, incumbrances, interest or advancements.

On demand after date for value received I (we) promise to pay to the order of Archer National

Bank the sum of Forty-five thousand and no/100 Dollars

at the office of the legal holder of this instrument with interest at 6 per cent. per annum after date hereof until paid.

It is to be understood that the grantors hereby agree to pay to the grantee the sum of \$45,000.00 on or before the date hereof, and to pay the same to the grantee in installments of \$1,500.00 per month, beginning on the first day of the month of January, 1988, and continuing until the sum of \$45,000.00 has been paid in full. The grantee shall retain title to the premises until the sum of \$45,000.00 has been paid in full. The grantors shall be responsible for the payment of all taxes and assessments on the premises until the sum of \$45,000.00 has been paid in full. The grantee shall have the right to sell the premises if the grantors fail to pay the installments as provided herein. The grantors shall be responsible for the payment of all interest on the loan. The grantee shall have the right to foreclose on the premises if the grantors fail to pay the interest as provided herein. The grantors shall be responsible for the payment of all legal fees and costs incurred by the grantee in connection with this instrument. 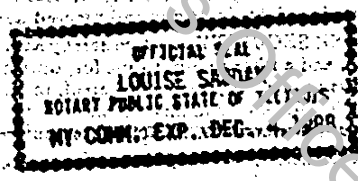
