
which survey is attached to the Declaration of Condominium recorded as Document No. 25086543, together with its undivided percentage interest in the Common Elements.

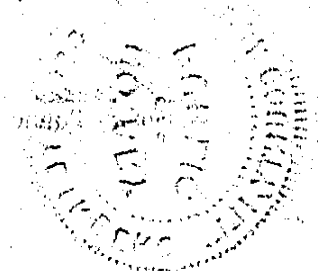
