MODIFICATION AGREEMENT

- D. Borrower and Lender mutually desire to modify the terms and conditions of the Note and Mortgage;

NOW, THEREFORE, the parties, notwithstanding anything contained to the contrary in the Note or Mortgage agree as follows:

- 1. The principal sum of \$53,972.70 plus interest on the balance of principal remaining from time to time at the rate of 10% per annum as follows: \$518.83 monthly beginning February 1, 1988 and monthly thereafter until the final payment on January 1, 1993.
- Except as modified by this Modification Agreement, all of the provisions of the Note and Mortgage shall remain in full force and effect.
