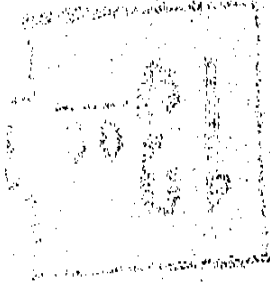

LEGAL DESCRIPTION

BLOCK 9 IN THE ASSESSOR'S DIVISION OF THAT PART EAST OF THE CHICAGO RIVER OF THE EAST 1/2 OF THE NORTH WEST 1/4 OF SECTION 9, TOWNSHIP 39 NORTH, RANGE 14, EAST OF THE THIRD PRINCIPAL MERIDIAN, EXCEPT THAT PART OF SAID BLOCK 9 DESCRIBED AS FOLLOWS:

BEGINNING AT THE NORTHEASTERNLY CORNER OF SAID BLOCK 9 AND RUNNING: THENCE SOUTHEASTWARDLY ALONG THE NORTHEASTERLY LINE OF SAID BLOCK 9, A DISTANCE OF 193.13 FEET; THENCE SOUTHWESTWARDLY, PERPENDICULAR TO THE LAST DESCRIBED COURSE, A DISTANCE OF 250.05 FEET TO A POINT ON THE EASTERLY DOCK LINE OF THE NORTH BRANCH OF THE CHICAGO RIVER AS ESTABLISHED BY ORDINANCE OF DECEMBER 4, 1854; THENCE NORTHWESTWARDLY ALONG SAID DOCK LINE 196.10 FEET TO AN ANGLE POINT IN SAID DOCK LINE; THENCE NORTHWESTWARDLY ALONG SAID DOCK LINE WHICH LINE FORMS AN ANGLE OF 6 DEGREES TO THE RIGHT WITH A PROLONGATION OF THE LAST DESCRIBED COURSE, A DISTANCE OF 89.20 FEET TO A POINT ON THE NORTH LINE OF SAID BLOCK 9; AND THENCE EAST ALONG THE NORTH LINE OF SAID BLOCK 9, A DISTANCE OF 219.97 FEET TO THE POINT OF BEGINNING, ALL IN THE CITY OF CHICAGO, COUNTY OF COOK, STATE OF ILLINOIS.
