

## Excerpts From Internal Revenue Colle

Sec. 6321, Lien For Taxes.

If any person liable to pay any lax neglects or refuses to topy the same after demand, the amount fincluding any inter-1, additional amount, addition to tax, or assessable penalty, sgether with any costs that may accrue in addition thereto). shall be a lien in favor of the United States upon all property and rights to propiety, whether rask or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by raw, the lien appeal by section (921 shall arise at the time the assessment is made and shall continue until the liability for the amount so sessed (or a judgment against the taxpayer arising out of uch ilability) is satisfied or becomes unenforceable by reason

Sec. 8923. Validity and Priority Against Certain Persons.

(a) Phirchaser's, Holders Of Security inrests, Mechanic's Lienors, And Judgment Lien Cryditors. -- The iten imposed by section \$321 shall not be valid as against any purchaser, holder of a security #1078. -- The Net Imposed by section \$321 shall echanic's flenor, or judgment flen creditor until natice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

## (7) Place For Filling Notice; Form.-

(1) Place For Filling - The notice referred to in subsection (a) shall be filed -

(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State for the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the ilen is situated; and

(ii) Personal Property - in the case of personal property, whether tangible or intangible, in one office within the State for the county, or other governmental subdivision), as designated by the faws of such State, in which the property subject to the lien is situated;

(B) With Clerk Of District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to lien is cituated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Lleeds Of The District Of Columbia - In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lies is situated in the District of Columbia

(Z) Situs Of Property Subject To Lien - For purposes of paragraphs (1) and (4), property shall be deemed to be situated -

(A) Real Property - in the case of real property, at its physical location; or

(B) Personal Property - in the case of personal property. ther tangible or intangible, at the residence of the taxpi yer at the time the notice of ilen is filed.

For mirpower of paragraph (2) (B), the residence of a corporation or part erst ip shall be deemed to be the place at which the principal or out've office of the business is located, and the residence of a far eyer whose residence is without the United States shall be (or ned to be in the District of Columbia

(8) Form - The form and coment of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice the walld notwithstanding any other provision of law regard to the form or content of a nation of lien.

- (g) Refilling Of Notice. For purposes of this section
- (1) General Aule. Unless notice of tien is relified in the manner prescribed in paragraph (2) during the required retiting period, such notice of lies; shall be treated as filed on the date on which it is filed (in accordance with subsection (f)) after the expiration of such refiling period.
- (2) Place For Filing. A notice of lien refiled during the required refiling period shall be effective only.

- (t) such notice of tien is refilled in the office in which the prior notice of lien was filed, and
- (iii) in the case of real property, the fact of refiling is entered and recorded in an index to the extent required by subsection (f) (4), and
- (B) In any case in which, 90 days or more prior to the date of a retilling of notice of lien under subparagraph (A), the

Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the texpayer's residence, if a notice of such lien is also filed in accordance with subsection (f) in the State in which such residence is located.

(3) Required Refilling Period. — in the case of any notice of iten, the term "required refiling period" means -(A) the one-year period ending 30 days after the expiration of 6 years after the date of the assessment of the tax, and (B) the one-year period ending with the expiration of 6 years

after the close of the preceding required refilling partod for auch notice of Hen.

6325. Release Of Lien Or Sec. Discharge Of Property.

- Of Lien. Subject to each (a) Release regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any tien imposed with respect to any internal revenue tex not later than 30 days after the day on which -
- (1) Liability Satisfied or Unenforceable The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has become legally unenforceable; or
- (2) Bond Accepted There is furnished to the Secretary and arcosted by him a bond that is conditioned upon the payment of the amount assessed, together with all interest in respect thereof within the time prescribed by law (including any extens on of such time), and that is in accordance with such requirences resting to terms, conditions, and form of the bond and sureties the Jon, as may be specified by such regulations.

Sec. 6103. Confidentiality and Disclosure of Returns and Return Information.

- (k) Disclosure of Certain Returns and Return Information For Tax Administration Purposes. -
- (2) Discipsure of amount of outstanding lien. if a notice of lien has been filled pursuant to section 6323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person wno furnishes satisfactory written evidence that he has a right in the property subject to such lien or intends to obtain a right in such property
