for and in said improvement, and that on November 28th, 1987, the claimant completed thereunder 90% of contract work & extras in the amount of \$6437.70 as of 11/28/87

That at the special instance and request of said contractor the claimant furnished extra and additional materials at and extra and additional labor on said premises of the value of \$ 1839.00 and completed same on SEE ABOVE

That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows: \$2000.00

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of (\$5153.00) Fifty-one Hundred Fifty-three and NO/100 Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
