THIS INDENTURE, made FEBRUARY 19, 1988, between FREDERICK H. OWARE AND

VERONICA H. OWARE, HIS WIFE AS JOINT TENANTS AS TO 2/3 INTEREST & JULIET BOADU AS TO  
herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES A DELAWARE corporation, herein referred to as TRUSTEE, witnesseth:
