IT IS HEREBY ORDERED THAT:

The Judgment for Dissolution of Marriage entered on September 12, 1979 is hereby modified as follows:

1. Paragraph 2 shall be modified, by adding the following language:

When Douglas is residing with Husband, for a period of time of one (1) week or more, Husband shall not pay to Wife the weekly pro-rata amount of child support, for Douglas, and Wife shall not be obligated to pay any child support to Husband, for Douglas.

2. Paragraph 5 shall be modified as follows:

Wife shall be responsible for future college education expenses of Dale and Husband shall be responsible for future college

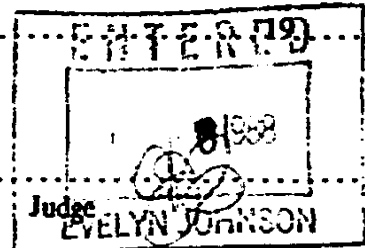
