AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

88090437

WHEREAS, there was filed with the Clerk of the Village of Glenview, a home rule municipality on February 12, 1988, a certain petition to annex to the said Village of Glenview, property hereinafter described; and

WHEREAS, the President and Board of Trustees of the Village of Glenview have independently determined that said property described in the aforesaid petition is not within the corporate limits of any municipality, that it is contiguous to the present village limits of the Village of Glenview, and that all property owners, and electors have signed said petition as required by statute.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The property commonly known as 2760 Willow Road and is legally described as:

The West 532.15 feet of Tract 2 of Abel's Division of the Southerly 20 acres of the West Half of the North West Quarter lying North of the Center line of Willow Road as dedicated of record in the Office of the Recorder of Deeds of Cook County, Illinois in Document 11231380 Book 306 Page 47, 48 and 49 and North of said center line as extended to the center line of Pflingsten Road in Section 21, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

The West 532.15 feet of Tract 1 of Abel's Division of the Southerly 20 acres of the West Half of the North West Quarter lying North of the Center line of Willow Road as dedicated of record in the Office of the Recorder of Deeds of Cook County, Illinois in Document 11231380 Book 306 Page 47, 48, 49 and North of said center line as extended to the center line of Pflingsten Road in Section 21, Township 42 North, Range 12 East of the Third Principal Meridian, in Cook County, Illinois.

The foregoing legally described land consists of contiguous parcels, comprising approximately eight (8) acres, located at the Northeast corner of Pflingsten Road and Willow Road, bounded by Willow Road on the South and Pflingsten Road on the West, and the Village of Glenview limits on the South.


Section 4: Every section and provision of this ordinance shall be separable, and the invalidity of any portion of this ordinance shall not affect the validity of any other portion hereof.

Section 5: This ordinance shall take effect upon its passage, and approval according to law.




