AN ORDINANCE TO ANNEX CERTAIN TERRITORY  
TO THE VILLAGE OF GLENVIEW, COOK COUNTY,  
ILLINOIS

WHEREAS, there was filed with the Clerk of the Village of Glenview, a home rule municipality on February 12, 1988, a certain petition to annex to the said Village of Glenview, property hereinafter described; and

WHEREAS, the President and Board of Trustees of the Village of Glenview have independently determined that said property described in the aforesaid petition is not within the corporate limits of any municipality, that it is contiguous to the present village limits of the Village of Glenview, and that all property owners, and electors have signed said petition as required by statute.

NOW, THEREFORE, BE IT ORDAINED, by the President and Board of Trustees of the Village of Glenview, Cook County, Illinois, that

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.

Section 2: The property commonly known as the Northwest Corner of Willow and Pfingsten Roads and is legally described as:

The South 251 feet of the East 263.87 feet of the South 1/2 of the North 1/2 of the North East 1/4 of Section 20, Township 42 North, Range 12 East of the Third Principal Meridian, (Excepting therefrom that part thereof conveyed to the State of Illinois by Deed recorded January 28, 1970 as Document 21068116), in Cook County, Illinois.

AND

That part of the South 1/2 of the North 1/2 of the North East 1/4 of Section 20, Township 42 North, Range 12 East of the Third Principal Meridian, bounded and described as follows:

Beginning on the South line of the North 1/2 of the North East 1/4 of said Section at a point 263.87 feet West of the East line of the North East 1/4 of said Section; Thence running West 264.92 feet along the South line of the North 1/2 of the North East 1/4 of said Section; Thence North 330 feet parallel to the East line of the North East 1/4 of said Section; Thence East 264.92 feet parallel to the South line of the North 1/2 of the North East 1/4 of said Section; Thence South 330 feet parallel to the East line of the North East 1/4 of said Section, being the point of beginning, in Cook County, Illinois.

be and the same is hereby annexed to the Village of Glenview, Cook County, Illinois, pursuant to the provisions of Chapter 24, Section 7-1-8 of the Illinois Municipal Code of 1961, as amended.
