WHICH MORTGAGE was subsequently assigned by POTTS & CO. to Georgia-Teachers, as Nominee for Teachers' Retirement System of Georgia by an Assignment of Mortgage recorded November 2, 1983, with said Recorder as Instrument No. 26845945; ✓

WHICH MORTGAGE was subsequently assigned by Georgia-Teachers, as nominee for Teachers' Retirement System of Georgia to Teachers' Retirement System of Georgia by an Assignment of Mortgage recorded 1/12/88, with said Recorder as Instrument No. 88015695 ✓.
