**ORDER PERMANENT INJUNCTION**

This cause coming on to be heard, the Court having jurisdiction of the parties and the subject matter, due notice having been given, and the Court having heard testimony and otherwise being fully advised in the premises:

**THE COURT FINDS:**

1. That on the premises commonly known as 01130 W THORNDALE Chicago, Illinois, there is a 0002 unit building.
2. That the legal description of said premises is \*THE E. 50' OF LOT 18 & THE E 50' OF THE S1/2 OF LOT 19 IN BLK 13 IN COCHRAN'S 2ND ADDN TO EDGEWATER SECT 5 TWSP 40 NORTH RANGE 14 LYING EAST OF THE 3RD PRINCIPAL MERIDIAN IN COOK COUNTY IL (PI# 14-05-712-013) *JAO ALL*
3. That by competent evidence, the Plaintiff has demonstrated that the subject premises fails to conform in all respects to the minimum standards of health and safety established by the Municipal Code of the City of Chicago, as set forth in Plaintiff's Complaint.

**WHEREFORE, IT IS HEREBY ORDERED:**

- A. That the Defendants KARATITSOS, PETER their agents, heirs, successors or assigns, be and are hereby permanently enjoined and restrained from USING THE SUBJECT PREMISES OTHER THAN AS A GARAGE AND NOT AS AN AUTO REPAIR SHOP
- B. That this Court shall retain jurisdiction of this matter for the purpose of enforcing the provisions of this Order.
- C. That this cause be and is hereby disposed subject to the permanent injunction aforesaid. This order is final and appealable, the court finding no just reason to delay enforcement or appeal.

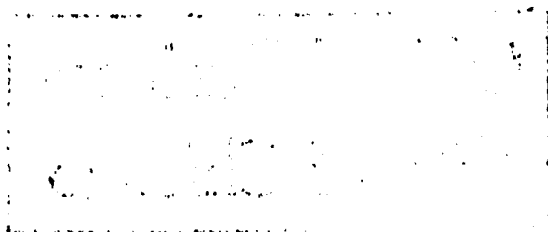
