DECLARATION OF CONDOMINIUM OWNERSHIP

THIS FIRST AMENDMENT is made and entered into by AMERICAN NATIONAL BANK AND TRUST COMPANY OF CHICAGO, a national banking association, not individually but as Trustee under Trust Agreement dated May 4, 1987 and known as Trust No. 102386-08 ("Trustee").

#### WITNESSETH:

WHEREAS, gursuant to the provisions of a certain Declaration of Condominium ownership for Carriage way of Burr Ridge Condominium, Burr Ridge, Illinois ("Declaration"), recorded in the Office of the Recorder of Daeds of Cook County, Illinois as Document Number 87607850, the Trustee submitted certain real estate to the Condominium Property Act of the State of Illinois; and said real estate and the improvements situated thereon are commonly known as Carriage Way of Burr Ridge Condominium in Burr Ridge, Illinois; and

WHEREAS, pursuant to the provisions of the Declaration, Carriage Way of Burr Ridge Partnership desires to amend the Declaration as hereinafter set forth;

NOW, THEREFORE, the Trustee does hereby amend the Declaration as follows:

- 1. Paragraph 1(c) of Article II of the Leclaration is hereby deleted in its entirety and a new Paragraph 1(z) of Article II is inserted in its place to read as follows:
  - (c) No Unit Owner (other than the Trustee) shall, by deed, plat, court decree or otherwise, combine or subdivide or in any other manner cause any Unit owned by such Unit Owner (other than the Trustee) to be separated into any tracts or parcels different from the whole Unit as shown on the Plat. Notwithstanding the foregoing, the Trustee shall have the right at any time and from time to time (i) to combine any part or all of a Unit or Units owned by it for the purpose of increasing the size of such Unit or Units and

eliminating or reducing the size of another Unit or other Units owned by it and the Trustee shall have the right in connection therewith, at Trustee's own expense, to locate or relocate Common Elements affected or required by such combination, (ii) to incorporate any part or all of the Common Elements located in the storage areas adjacent to and behind the trash shoots above the basement level into an adjoining Unit and (iii) to convert any part or all of the Common Elements located in the storage areas adjacent to and behind the trash shoots above the basement level into a separate Unit.

- Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
- This Declaration is executed by American National Bank and Trust Company of Chicago, as Trustee aforesaid and not individually, in the exercise of the power and authority conferred upon and vested in it as such Trustee (and said Bank hereby represents that it possesses full power and authority to execute this instrument). All the terms, provisions, stipulations, covenants and conditions to be performed by American National Bank and Trust Company of Chicago are undertaken by it solely as Trustee aforesaid, and not individually, and all statements herein made are made on information and belief and are to be construed accordingly, and no personal liability shall be asserted or be enforceable against said Bank by reason of any of the terms, provisions, stipulations, covenants and/or statements contained in this instrument.
