RESCISSION AGREEMENT





3. That this agreement shall nullify any and all prior existing agreements between the parties.



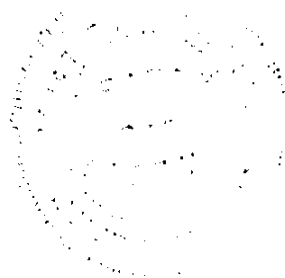
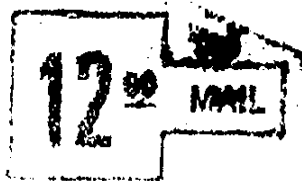
