SUBORDINATION AGREEMENT

- 1. - 4. Pursuant to the terms and conditions of the loan commitment issued by Great-West, Two Million Five Hundred Twelve Thousand Nine Hundred Forty Two and No/100 Dollars (\$2,512,942.00) of the Great-West loan proceeds will be disbursed to First Interstate and applied by First Interstate on account of the First Interstate Loan. The balance of the Great-West loan proceeds, Three Hundred Eighty Seven Thousand Fifty Eight and No/100 Dollars (\$387,058.00), will be retained in escrow pending the satisfaction of the rental achievement requirements contained in the loan commitment issued by Great-West.
- 5. To effect the funding of the Great-West loan, First Interstate has agreed to subordinate the documents which secure the First Interstate Loan to the documents which will secure the Great-West Loan.

NOW, THEREFORE, THIS AGREEMENT, WITNESSETH:

THAT for and in consideration of the sum of Ten Dollars (\$10.00) and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged:

- 1. First Interstate hereby acknowledges receipt of the sum of TWO MILLION FIVE HUNDRED TWELVE THOUSAND NINE HUNDRED FORTY TWO AND NO/100 DOLLARS (\$2,512,942.00), which sum has been applied by First Interstate to the unpaid principal balance of the First Interstate Loan and after applying said sum, the unpaid principal balance of the First Interstate Loan is FOUR HUNDRED EIGHTEEN THOUSAND EIGHTY SEVEN AND 39/100 DOLLARS (\$418,087.39).
- 2. First Interstate does bereby covenant and agree with Great-West that as of the date hereof, the First Interstate Mortgage and First Interstate Assignment of Leases and Rents shall be and remain at all times a second lien upon the premises described in the Great-West Mortgage and that the First Interstate Mortgage and First Interstate Assignment of Leases and Rents shall be and remain subject and subordinate to the lien of the Great-West Mortgage and any other documents given to additionally secure the Great-West Note.
