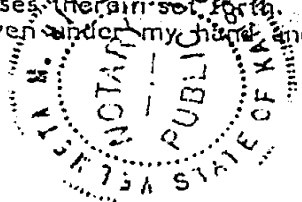

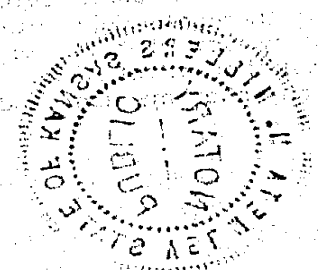
WHEREAS, the State of Illinois is entitled to the
