THIS INDENTURE, made March 21st, 19 88, between Fidel Gonzalez and Elena Gonzalez, his wife as joint tenants.

herein referred to as "Mortgagors," and CHICAGO TITLE AND TRUST COMPANY, an Illinois corporation doing business in Chicago, Illinois, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder or holders being herein referred to as Holders of the Note, in the principal sum of \$64,504.04

and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest from March 29th, 1988 on the balance of principal remaining from time to time unpaid at the rate of 13.5 per cent per annum in instalments (including principal and interest) as follows: \$816.13

Eight hundred and sixteen dollars & 13/100 Dollars or more on the 10th day of April, 19 88, and \$816.13 Dollars or more on the 10th day of each month thereafter until said note is fully paid except that the final payment of principal and interest, if not sooner paid, shall be due on the 10th day of March 2003.

All such payments on account of the indebtedness evidenced by said note to be first applied to interest on the unpaid principal balance and the remainder to principal: provided that the principal of each instalment unless paid when due shall bear interest at the rate of 25 per annum, and all of said principal and interest being made payable at such banking house or trust company in Chicago Illinois, as the holders of the note may, from time to time, in writing appoint, and in absence of such appointment, then at the office of Security Federal Savings & Loan in said City.
