Exhibit D attached to the Declaration is hereby amended and superseded in its entirety by Exhibit D attached hereto, and the respective percentages of ownership in the Common Elements appurtenant to each Dwelling Unit described in said Exhibit D prior to this Amendment is hereby reduced to the respective percentages set forth in Exhibit D as hereby amended.
- 5. The additional Common Elements are hereby granted and conveyed to the Grantees of Dwelling Units heretofore conveyed, all as set forth in the Declaration.
- 6. Except as expressly set forth herein, the Declaration shall remain in full force and effect in accordance with its terms.
