THIS INDENTURE, made MARCH 21 19 88, between AUDREY E. ASKINS TIMMS

Divorced and since then not remarried A DELAWARE herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES, a corporation, herein referred to as TRUSTEE, witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holders of the Instalment Note hereinafter described, said legal holder being herein referred to as Holder of the Note, in the principal sum of \$29,122.00
