and valuable considerations in hand paid, Convey and Warrant unto the CHICAGO TITLE AND

60602, as Trustee under the provisions of a trust agreement dated the 1st
day of March 1988 known as Trust Number 1091166 the following described Real estate in
the County of Cook and State of Illinois, to-wit:

The grantor and grantee in witness whereof have hereunto set their hands and affixed their seals, and do hereby declare that the said premises or any part thereof, to dedicate parks, streets, highways, alleys and ways in the said lots, to sell, lease, let, give, convey, exchange, barter, exchange, mortgage, alienate, or otherwise encumber said property, or any
part thereof, to lease said property, or any part thereof, for any term or time, and to renew or extend leases upon any terms and for any period or for any period of time, and to amend, change or modify leases and the rents and other charges thereon, at any time or times hereafter, to contract to make leases and to grant options to lease and options to renew leases and options to purchase the whole or any part thereof, to let, to contract respecting the manner of fixing the amount of present or future rentals, to partition or exchange said premises and options to purchase said property, for other real or personal property, to grant easements or charges of any kind, to release, convey or assign the right title or interest in or about or in connection therewith, to deal with said property and every part thereof in all other ways and for such other considerations as would be looked for by persons owning the same to deal with the same whether similar to or different from the ways above specified, at any
time or times hereafter.

The grantor and grantee, together with and through the instrument of conveyance, or instruments of assignment, shall be entitled, contracted to be sold, leased or mortgaged by said trustee, by said trustee to the applicant, for such sum or sums, or amounts borrowed or advanced on said premises, or be obliged to sell, lease or mortgaged by said trustee, or be obliged to incur into the necessity of executing on any act of said trustee, or be obliged or privileged to institute or cause the delivery of the terms of said trust agreement, and every deed, trust deed, mortgage, lease or other instrument executed by said trustee in relation to said real estate shall be conclusive evidence in favor of every person relying upon it claiming under any such conveyance, lease or other instrument, (a) that at the time of the delivery thereof the trust created by this indenture and by said trust agreement was in full force and effect, (b) that such conveyance or other instrument was executed in accordance with the trust, conditions and limitations contained in this indenture and in trust agreement or some amendment in force and binding upon all beneficiaries thereunder, (c) that said trustee was duly authorized and empowered to execute and deliver every such deed, trust deed, lease, mortgage or other instrument and (d) if the conveyance is made to a successor or successors in title, that such successor or successors in title have been properly apprised and are fully vested with all the title, estate, rights, powers, authorities, duties and obligations of his or her predecessor in title.

The interest of each and every beneficiary herein for and of all persons claiming under them, *any of them shall be a party to the earnings, avails and proceeds arising from the sale or other disposition of said real estate, and such interest is hereby declared to be personal property, and no beneficiary or founder shall have any title or interest, legal or equitable, in or to said real estate, as such, but may be entitled to the earnings, avails and proceeds, as aforesaid.*

In the event of the above funds to now or hereafter be stated, the Register of Titles is hereby directed not to enter a note on the certificate of title or duplicate record, but to enter the words "in trust" or "trust" in the margin of the title, in accordance with the statute in such case made and provided.

At the said date the grantor hereby expresses his desire and consents that the same be recorded and by virtue of any laws or statutes of the State of Illinois, proceeding for the collection of homestead from said or execution of all taxes.
