MEMORANDUM OF BLACK RAM, INC., GROUND AND BUILDING LEASE EXTENSION AGREEMENT

This Memorandum of Lease and Extension Agreement made this 2/4/ day of
March , 1988, by and between MOUNT PROSPECT STATE BANK, as
Trustee under Trust Agreement dated March 16, 1971, and known as Trust No.
181, (hereinafter referred to as the "Lessor") and the BLACK RAM, INC., an
Illinois corporation (hereinafter referred to as the "Lessee").

WITNESSETH:

1. Lessor and Lessee on March 1, 1985, entered into a lease of the following legally-described real estate:

Lot 1 in Mandas Resubdivision of Lots 9, 10, 12, 13 and 14 in Block 16 in Arthur T. McIntosh and Co.'s Addition to Des Plaines Heights, being a subdivision of that part East of Railroad of the South 1/2 of the South East 1/4 of Section 20, Township 41 North, Ranga 12, East of the Third Principal Meridian, and of that part West of Des Plaines Road of the South 1/2 of the South West 1/4 (except 4 acres in the North East corner thereof) of Section 21, Township 41 North, Range 12, East of the Third Principal Meridian, in Cook County, Illinois.

- 2. The lease sets forth the names and addresses of the parties thereto.
- 3. The term of the lease is twenty-five (25) years commencing on March 1, 1985, and ending on February 28, 2010. Lessor and Lessee on November 25, 1985, entered into a rider extending the term of the lease an enditional two (2) years to February 29, 2012.
- 4. Lessor and Lessee have this day entered into an Extension Agreement extending the term of the lease an additional three (3) years to February 28, 2015 and modifying the provisions of the lease in other respects.
- 5. The lease contains provisions giving the Lessee a right of first refusal in the event the Lessor shall receive an offer from any person to purchase the leased premises.

This instrument is signed by Mount Prospect State Bank, not personally but solely as Trustee under a certain Trust Agreement known as Trust No. 181. Said Trust Agreement is hereby made a part hereof and any claims against said Trustee which may result from the signing of this Agreement shall be payable only out of any trust property which may be held thereunder, and said Trustee shall not be personally liable for the performance of any of the terms and

conditions express or implied of this Agreement or for the validity or condition of the title of said property or for any agreement with respect thereto. Any and all personal liability of Mount Prospect State Bank is hereby expressly waived by the parties hereto and their respective successors and assigns.
