Part of Lots 1 and 2 (taken as a tract) in the Subdivision of the North 462 feet of that part of the North West 1/4 lying Westerly of the Westerly right of way of the Illinois Central Railroad and that part of the North West 1/4 of Section 6, all in Township 35 North, Range 14 East of the Third Principal Meridian, described as follows:


