ORDINANCE NO. 37-7

SOUTH BARRINGTON PARK DISTRICT

ANNEXATION OF LAND

Section 1. The South Barrington Park District is operating
all its territory predominantly in the Village of South
Barrington;

and, therefore, the South Barrington Park District would become
conterminous or nearly conterminous with said Village of South
Barrington in the annexation of additional territory within
said Village of South Barrington but not incorporated within a
park district;

and, therefore, said additional territory is described in Section 2
hereof, and said territory is within the Village of South
Barrington, is contiguous to the South Barrington Park District
and is not located or incorporated within any other park
district;

and, therefore, it is recommended by the Board of Park
Commissioners of the South Barrington Park District, and
it is hereby ordered, that:

Section 2. The Board of Park Commissioners of the South
Barrington Park District hereby finds that the statements
set forth in the preamble to this Ordinance are true and correct,

Section 2. The following described territory is hereby
granted to the South Barrington Park District:

That part of the North 1/2 of Section 22, Township 42 North,
Range 1 East of the third principal meridian described as
follows: Beginning at a point on the South line of the
Northwest 1/4 of said Section 22 that is 1015.00 feet West of the
southeast corner of said Northeast 1/4; thence northerly along a
line (hereafter referred to as line "A"), a distance of 1209.56
feet to a point on the center line of Algonquin Road (State Route
5) that is 1737.00 feet Northwest of (measured along said
center line) the East line of said Northwest 1/4; thence
northerly along said center line, being along a curve to the
right, a distance of 57.60 feet to the point of beginning;
thence continuing westerly along said center line, being
along a curve to the right, a distance of 523.2 feet; thence
westerly, a distance of 297.64 feet to a point on the South
line of the Northwest 1/4 of said Section 22, which is 603.35 feet
West of the southwest corner of the East 1/2 of said Northwest
1/4; thence easterly along the South line of the Northwest 1/4 of
said Section 22 and along the South line of the Northeast 1/4 of
said Section 22, a distance of 1315.39 feet to a point on the
center line of said Northeast 1/4 that is 727.47 feet west of said
line "A" (as measured along said South line); thence Northerly
parallel with said line "A", a distance of 322.95 feet; thence
Easterly at right angles to the last described course, a distance
of 342.75 feet; thence Northerly parallel with said line "A", a
distance of 964.86 feet to the point of beginning in Barrington
Township, Cook County, Illinois.

Section 3. The secretary of the District is hereby directed
to have certified copy of this Ordinance and an accurate map of
the above described territory, which is attached hereto and made a part
hereof, with the office of the County Clerk and County Recorder
in Cook County, Illinois.
