

NOW, THEREFORE, the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Chesterfield on Touhy Condominium Association is hereby amended in accordance with the

WHEREAS, the amendment has been approved in writing by the acknowledged signatures of a majority of the Board members and signed and acknowledged by three-fourths (3/4) of the unit owners, in compliance with Article XII, Section 7 of the Declaration, and due notice having been provided to all mortgagees holding bona fide liens of record against any unit ownership;

WHEREAS, the Board and the Owners desire to amend the Declaration in order to establish an orderly policy for voting; and

WHEREAS, by the Declaration recorded in the Office of the Recorder of Deeds of Cook County, Illinois, the Property has been submitted to the provisions of the Illinois Condominium Property Act; and

RECITALS

This Amendment is adopted pursuant to the provisions of Article XII, Section 7 of the aforesaid Declaration. Said section provides that this Amendment, the text of which is set forth below, shall become effective upon recordation in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is signed and acknowledged by a majority of the Board of Managers of Chesterfield on Touhy Condominium Association (the "Board"), signed and acknowledged by at least three-fourths (3/4) of the unit owners and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees, having bona fide liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for Chesterfield on Touhy Condominium Association (hereafter the "Association"), which Declaration was recorded on August 9, 1971, as Document No. 21576982 and amended by Document No. 85133347 recorded in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described on Exhibit "A" attached hereto.

2. Except to the extent expressly set forth herein above, the remaining provisions of the Declaration shall continue in effect without change.

6. Board of Managers (Board of Directors). (a) Elections. At the initial meeting and at each annual meeting of the Association thereafter, the Unit Owners shall elect at large a Board of Managers. In all elections for members of the Board of Managers, the candidates receiving the highest number of votes with respect to the number of offices to be filled shall be deemed to be elected. Members of the Board elected at the initial meeting shall serve until the first annual meeting of the Association. At the first annual meeting the nine (9) Board members shall be elected. The five (5) persons receiving the highest number of votes at the first annual meeting shall be elected to the Board for a term of two (2) years, and the four (4) persons receiving the next highest number of votes shall be elected to the Board for a term of one (1) year. Upon the expiration of the terms of the office of the Board members so elected at the first annual meeting of the Association and thereafter, successors shall be elected for a term of two (2) years each. The Unit Owners having at least two-thirds (2/3) of the total votes may from time to time increase or decrease such number of persons on the Board or may increase or decrease the term of office of the Board members at any annual or special meeting, provided that such members shall not be less than three (3), that the terms of at least one-third (1/3) of the persons on the Board shall expire annually, and at the terms of no existing Board members may be increased or decreased during his/her term. Amend to seven (7) Board members. Members of the Board shall receive no compensation for their services, unless expressly approved by the Board at the direction of the Unit Owners having two-thirds (2/3) of the total votes. Where the number of persons on the Board has been increased or there is a loss of a Board member for any reason (resignation, death, sale, etc.) such additional Board members shall be elected at the next annual meeting of the Association or at a special meeting of the Unit Owners called for such purpose.
