This Amendment is adopted pursuant to the provisions of Article XII, Section 7 of the aforesaid Declaration. Said section provides that this Amendment, the text of which is set forth below, shall become effective upon recording in the Office of the Recorder of Deeds of Cook County, Illinois, of an instrument in writing setting forth the change, provided the same is signed and acknowledged by a majority of the Board of Managers of Chesterfield on Touhy Condominium Association (the "Board"), signed and acknowledged by at least three-fourths (3/4) of the unit owners and provided further that it contains an affidavit by an officer of the Board, certifying that a copy of the change has been sent by certified mail to all mortgagees, having bona fide liens of record against any unit ownership, not less than ten (10) days prior to the date of such affidavit.

This document is recorded for the purpose of amending the Declaration of Condominium Ownership and of Easements, Restrictions and Covenants (hereafter the "Declaration") for Chesterfield on Touhy Condominium Association (hereafter the "Association"), which Declaration was recorded on August 9, 1971, as Document No. 21576982 and amended by Document No. 85133347 recorded in the Office of the Recorder of Deeds of Cook County, Illinois, and covers the property (hereafter the "Property") legally described on Exhibit "A" attached hereto.

(b) Subsection (a) of this Section 1 shall not apply to the rental or leasing of units by any Owner or contract purchaser as of the date of recordation of the amendment enacting this Subsection (b).

(a) Leasing, Rental or Leasing of Units is prohibited, except as hereinafter provided. To meet special situations and to avoid undue hardship or practical difficulties, the Board of Managers may, but is not required to, grant permission to a Unit Owner to lease his Unit to a specified lessee for a period of not less than six (6) consecutive months nor more than twelve (12) months on such other reasonable terms as the Board may establish. Such permission may be granted by the Board only upon the written application by the Unit Owner to the Board. The Board shall respond to each application in writing within thirty (30) days of the date of the application. All requests for extension of the original lease must also be submitted to the Board in the same manner as set forth for the original application. The Board has sole and complete discretion to approve or disapprove any Unit Owner's application for a lease or extension of a lease; provided, however, that in no event shall any Unit Owner be permitted to lease or rent such Unit for more than twenty-four (24) consecutive months. The Board's decision shall be final and binding.

1. Sale or Lease. Any owner other than the trustee who wishes to sell or lease his unit ownership pursuant to subsection (a), (b), (c) and (d) that governs leasing herein (or any lessee of any Unit wishing to assign or sublease such Unit) shall give the Board not less than thirty (30) days' prior written notice of the terms of any contemplated sale or lease, together with the name, address and financial and character references of the proposed purchaser or lessee and such other information considering the proposed purchaser or lessee as the Board may reasonably require. The members of the Board acting on behalf of the other owners shall at all times have the first right and option to purchase or lease such unit ownership upon the same terms, which option shall be exercisable for a period of thirty (30) days following the date of receipt of such notice. If said option is not exercised by the board within said thirty (30) days, the owner (or lessee) may, at the expiration of the said thirty (30) day period and at any time within ninety (90) days after the expiration of said period, contract to sell or lease (or sublease or assign) such Unit Ownership to the proposed purchaser or lessee named in such notice upon the terms specified therein. If the Owner (or lessee) fails to close said proposed sale or lease transaction within ninety (90) days, the Unit Ownership shall again become subject to the Boards right of the first refusal as herein provided.
