MORTGAGE

POSSESSION AND MAINTENANCE OF THE PROPERTY. Grantor agrees that its possession and use of the Property shall be governed by the following provisions:

Possession and Use. Until in default, Grantor may remain in possession and control of and operate and manage the Property and collect the Rents from the Property.

Duty to Maintain. Granter shall maintain the Property in first class condition and promptly perform all repairs and maintenance necessary to preserve

Hazardous Substances. Granter represents and warrants that the Property never has been, and never will be so long as this Mertgage remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9801, at seq. ("CERCLA"), applicable state laws, or regulations adopted pursuant to either of the foregoing. Granter agrees to indemnify and hold harmless Lender against any and all claims and losses resulting from a breach of this provision of the Mertgage. This obligation to indemnify shall survive the payment of the Indebtedness and satisfaction of this Mertgage.

Nulsance, Waste. Granter shall neither conduct or permit any nulsance nor commit or suffer any strip or waste on or to the Property or any portion thereof, including without limitation removal, or alienation by Granter of the right to remove, any timber, minerals (including oil and gas), or soil, or gravel or rock products.

Removal of Improvements. Grantor shall not demolish or remove any improvements from the Real Property Without the prior written consent of Lender. Lender shall consent? Grantor makes arrangements satisfactory to Lender to replace any improvements which Grantor proposes to remove with improvements of at least; qu'il value.

Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interests and to inspect the Property.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Grantor may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate applicable, so long as Grantor has notified Lender in writing prior to doing so and Londer's interests in the Property are not jeopardized. Lender may require Grantor to post adequate security or surety bond (reasonably satisfactory to Londer) to protect Londer's interest.

Duty to Protect. Grantor shall do all other acts, in addition to those acts set forth above in this section, that from the character and use of the Property are reasonably necessary to protect and preserve the Property.

DUE ON SALE - CONSENT BY LENDER. Londer may at its option declare inmediately due and payable all sums secured by this Merigage upon the sale or transfer of all or any part of the Real Property, or any interest therein, without the Lender's prior written consent. A "sale or transfer" means the conveyance of real property or any right, title or interest therein; whether legal or equitable; whether voluntary or involuntary; by outright sale; deed; installment sale contract; land contract; contract for deed; lesschold interest with a term propert than three years; lessc-option contract; sale, assignment or transfer of any beneficial interest in or to any land trust holding title to the Real Property; or any other method of conveyance of real property interest. If any Granter is a corporation, transfer also includes any change in ownership of more than 25% of the voling stock of Granter. However, this option shall not be exercised by Lender if exercise is prohibited by federal law or by illinois law.

TAXES AND LIENS

Payment. Grantor shall pay when due before they become delinquent all taxes, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due all claims for work done on or for services rendered or material furnished to the Property. Grantor shall maintain the Property free of all liens having priority over or equal to the interest of Lender under this Merigage, except for the lien of taxes and assessments not due, except for the prior indebtedness referred to believe, and except as otherwise provided in the following paragraph.

Right To Contest. Granter may withhold payment of any tax, assessment, or claim in connection with 1 good faith dispute over the obligation to pay, so long as Lender's interest in the Property is not joopardized. If a lien arises or is filled as a result of non-payment, Granter shall within 15 days affect the lien arises or, if a lien is filled, within 15 days affect Granter has notice of the illing, secure the discharge of the lien or deposit with Londer, cash, or a sufficient corporate surety bond or other security satisfactory to Londer in an amount sufficient to discharge the lien plus any conts, atterneys fees, or other charges that could accrue as a result of a foreclosure or sale under the lien. In any contest, Granter shall defend itself and Londer and shall satisfy any adverse judgment before enforcement against the Property. Granter shall name Londer as an additional obligoe under any surety bend furnished in the contest proceedings.

Evidence of Payment. Granter shall upon demand lumbsh to Lender evidence of payment of the taxes or assessments and sire an thorize the appropriate governmental efficial to deliver to Lender at any time a written statement of the taxes and assessments against the Property.

Notice of Construction. Granter shall notify Londer at least 15 days before any work is commenced, any services are furnished, or any materials are supplied to the Property, if any mechanics, materials and the cost exceeds \$1,000.00. Granter will on request turnish to Londer advance assurances satisfactory to Londer that Granter can and will pay the cost of such improvements.

PROPERTY DAMAGE INSURANCE.

Maintenance of insurance. Grantor shall procure and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of they collected and with a standard mortgagee clause in favor of Lendor. In no event shall the insurance be in an amount less than \$14,000.00. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lendor. Grantor shall deliver to Lender conflicates of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of 10 days prior written notice to Lender.

Application of Proceeds. Granter shall promptly notify Lander of any less or damage to the Property. Lender may make proof of less if Granter falls to do so within 15 days of the casualty. Lender may, at its election, apply the proceeds to the reduction of the indebtedness, payment of any lien affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Granter shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Granter from the proceeds for the reasonable cost of repair or restoration if Granter is not in default hereunder. Any proceeds which have not been disbursed within 180 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used to pay any amounts owing to Lender under this Mortgage, then to prepay accused interest, and then principal of the Indebtedness. If Lender

holds any proceeds after payment in full of the Indebtedness, such proceeds shall be paid to Grantor.

Unexpired Insurance at Sale. Any unexpired insurance shall inure to the benefit of, and pass to, the purchaser of the Property covered by this Morigage at any trustee's sale or other sale held under the provisions of this Morigage, or at any foreclosure sale of such Property.

Compliance With Prior Indebtedness. During the period in which any prior Indebtedness described below is in effect, compliance with the insurance provisions contained in the instrument evidencing such prior Indebtedness shall constitute compliance with the insurance provisions under this Mortgage, to the extent compliance with the terms of this Mortgage would constitute a duplication of insurance requirement. If any proceeds from the insurance become payable on loss, the provisions in this Mortgage for division of proceeds shall apply only to that portion of the proceeds not payable to the holder of the prior Indebtedness.

EXPENDITURES BY LENDER. If Grantor fails to comply with any provision of this Mortgago, including any obligation to maintain prior indebtodness in good standing as required below, or if any action or proceeding is commenced that would affect Lender's interests in the Property, Lender may, at its option, on Grantor's behalf take the required action and any amount that it expends in so doing shall be added to the indebtodness. Amounts so added shall be payable on demand with interest from the date of expenditure until paid at the Note rate. The rights provided for in this section shall be in addition to any other rights or any remedies to which Lender may be entitled on account of the default. By taking the required action, Lender shall not cure the default so as to bar it from any remedy that it otherwise would have had.

WARRANTY: DEFENSE OF TITLE.

Title. Grantor warrants that it holds marketable title of record to the Property in fee simple, free and clear of all liens and encumbrances other than those set forth in the prior indebtedness section below or in any policy of title insurance issued in favor of, and accepted by, Lender in connection with this Mortgage.

Defense of Title. Subject to are exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the event cry action or proceeding is commenced that questions Grantor's title or the interest of Lender under this Mortgage, Grantor shall defend the action at he carranse. Grantor may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and to be represented in the receding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as may be requested by it from time to time to permit such participation.

Compliance With Laws. Grantor warrants that his vise of the Property complies with all existing applicable laws, ordinances, and regulations of governmental authorities.

PRIOR INDEBTEDNESS. The following provisions concerning prior indebtedness are a part of this Mortgage:

Prior Lien. Grantor has informed Lender of the existence of a lien in the form of Eastland Mortgage Corp., which may have priority to the lien of this Mortgage. The obligation secured by the prior lien has a current principal balance of approximately \$9,000.00 and is in the original principal amount of \$. Grantor expressly covenants and agrees to pay or see it, the payment of the prior indebtedness and to prevent any default thereunder.

Default. If the payment of any installment of principal or any interest on the prior indebtedness is not made within the time required by the note evidencing such indebtedness, or should an event of default occur under the instrument securing such indebtedness and not be cured during any applicable grace period therein, then the indebtedness secured by this Mortgage shall, at the option of Lender, become immediately due and payable, and this Mortgage shall be in default.

No Modification. Grantor shall not enter into any agreement with the helder of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, amended, extended or renewed without the prior written consent of Lender. Grantor shall helther request nor accept any future advances under a prior mortgage, deed of trust, or other security agreement without the prior written consent of Lender.

CONDEMNATION.

Application of Net Proceeds. If all or any part of the Property is condemned, Londer may at its circular require that all or any portion of the net proceeds of the award shall mean the avair effor payment of all reasonable costs, expenses, and atterneys' less necessarily paid or incurred by Grantor, or Londer in connection with the condemnation.

Proceedings. If any proceedings in condemnation are filed, Grantor shall promptly notify Lender in writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. Grantor may be the nominal party in such proceeding but Lender shall be entitled to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor, will deliver or cause to be delivered, to Lender such instruments as may be requested by it from time to time to permit such participation.

IMPOSITION OF TAX BY STATE

State Taxes Covered. The following shall constitute state taxes to which this section applies: (a) a specific tax upon this ype of Mortgage or upon all or any part of the indebtedness secured by this Mortgage; (b) a specific tax on any Granter which the taxpayer is authorized or required to deduct from payments on the indebtedness secured by this type of Mortgage; (c) a tax on this type of Mortgage chargeable against the Lender or the holder of the Note; and (d) a specific tax on all or any portion of the indebtedness or on payments of principal and interest made by any Granter.

Remedies. If any state tax to which this section applies is enacted subsequent to the date of this Mortgage, this event shall have the same effect as a default, and Lender may exercise any or all of the remedies available to it in the event of a default unless the following conditions are met: (a) Granter may lawfully pay the tax or charge imposed by the state tax; and (b) Granter pays or offers to pay the tax or charge within 30 days after notice from Lender that the tax law has been enacted.

SECURITY AGREEMENT; FINANCING STATEMENTS.

Security Agreement. This instrument shall constitute a security agreement to the extent any of the Property constitutes fixtures or other personal property, and Lender shall have all of the rights of a secured party under the illinois Uniform Commercial Code.

Security interest. Upon request by Lender, Granter shall execute financing statements and take whatever other action is requested by Lender to perfect and continue Lender's security interest in the Rants and Personal Property. Granter hereby appoints Lender as Granter's atterney in fact for the purpose of executing any documents necessary to perfect or continue the security interest granted in the Rents and Personal Property. In addition to recording this Mortgage in the real property records, Lender may, at any time and without further authorization from Granter, life copies or reproductions of this Mortgage as a financing statement. Granter will reimburse Lender for all expenses incurred in perfecting or continuing this security interest. Upon default, Granter shall assemble the Personal Property and make it available to Lender within three days after receipt of written demand from Lender.

Addresses. The mailing address of Granter (debter) and the mailing address of Lender (secured party) from which information concerning the security interest granted by this Mortgage may be obtained (each as required by the Illineis Uniform Commercial Code) are as stated on the first page of this Mortgage.

FULL PERFORMANCE. If Grantor pays all of the Indebtedness when due and otherwise performs all the obligations imposed upon Granter under this Mortgage and the Note, Lender shall execute and deliver to Granter a suitable satisfaction of this Mortgage and suitable statements of fermination of any financing statement on file evidencing Lender's security interest in the Rents and the Personal Property. Granter will pay, if permitted by applicable law, any reasonable termination for as determined by Lender from time to time.

DEFAULT. The following shall constitute events of default:

Default on Indebtedness. Borrower falls to make any payment when due on the indebtedness.

Default on Other Payments. Failure of Grantor within the time required by this Mertgage to make any payment for taxes or insurance, or for any other payment necessary to prevent filling of or to effect discharge of any lien.

Compliance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Mortgage, the Note or in any of the Related Documents. It such a failure is curable and it Granter has not been given a notice of a breach of the same provision of this Mortgage within the preceding 12 months, it may be cured (and no event of default will have occurred) if Granter, after receiving written notice from Londer demanding cure of such failure: (c) cures the failure within 15 days; or (b) if the cure requires more than 15 days, immediately initiates steps sufficient to cure the failure and thereafter complete and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage, the Note or the Related Documents is, or at the unre made or furnished was, false in any material respect.

Insolvency. The insolvency of archor, appointment of a receiver for any part of Granter's property, any assignment for the benefit of creditors, the commencement of any proceeding encloses any bankruptcy or insolvency laws by or against Granter, or the dissolution or termination of Granter's existence as a going business (if Granter is a business). Except to the extent prohibited by toderal law or illinois law, the death of Granter (if Granter is an individual) also shall constitute an event of default unless this Mortgage.

Foreclosure, etc. Commencement of foreclosure, whether by judicial proceeding, self-help, repossession or any other method, by any creditor of Grantor against any of the Property, however this election shall not apply in the event of agood faith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure, provided that Grantor gives Lender written notice of such claim and furnishes reserves or a surety bond for the claim satisfactory to Lender.

Leasehold Default. If the interest of Grantor in the Property is a leasehold interest, any default by Grantor under the terms of the lease, or any other event (whether or not the fault of Grantor) that results in the in mination of Grantor's leasehold rights.

Breach of Other Agreement. Any breach by Granior under the tomes of any other agreement between Grantor and Lender that is not remedied within any grace period provided therein, including without limitation any agreement concerning any indebtedness or other obligation of Grantor to Lender, whether existing now or later.

Events Affecting Guarantors. Any of the preceding events occur with risplict to any guaranter of any of the Indebtedness of such guaranter dies or becomes incompetent, unless the obligations arising under the guaranty and foliated agreements have been unconditionally assumed by the guaranter's estate in a manner satisfactory to Lender.

Insecurity. If Lender reasonably dooms itself insecure.

Prior Indebtedness. Default of Grantor under any prior obligation or instrument securing any prior obligation, or commencement of any suit or other action to foreclose any prior lion on the Property.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any event of default and at any area thereafter, Londor may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by faw:

Accolerate Indebtedness. Lender shall have the right at its option without notice to Grantor to declar, the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.

UCC Remedies. With respect to all or any part of the Personal Property, Londer shall have all the rights of d remedies of a secured party under the illinois Uniform Commercial Code.

Collect Rants. Lender shall have the right, without notice to Grantor, to take possession of the Property and collect the Rants, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedness. In furthernice of this right, Lender may require any tenant or other user of the Property to make payments of rant or use fees directly to Lender. If the Ranto rice collected by Lender, then Grantor irrevocably designates Lender as Grantor's atterney in fact to enderse instruments received in payment thereof in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender's demand shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its rights under this subparagraph either in person, by agent, or through a receiver.

Mortgagee in Possession. Lender shall have the right to be placed as mortgagee in possession or to have a receiver appointed to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property proceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the indebtedness. The mortgagee in possession or receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the indebtedness by a substantial amount. Employment by Lender shall not disquality a person from serving as a receiver.

Judicial Foreclosure. Lender may obtain a judicial decree foreclosing Grantor's interest in all or any part of the Property.

Nonjudicial Sale. If permitted by applicable law, Lender may foreclose Granter's interest in all or any part of the Personal Property or the Real Property by nonjudicial sale.

Deficiency Judgment. If permitted by applicable law, Lender may obtain a judgment for any deficiency remaining in the indebtedness due to Lander after application of all amounts received from the exercise of the rights provided in this section.

Sale of the Property. To the extent permitted by applicable law, Granter hereby waives any and all right to have the property marshalled. In exercising its rights and remedies, Lander shall be free to sell all or any part of the Property together or separately, in one sale or by separate sales. Lender shall be entitled to bid at any public sale on all or any peritin of the Property.

Notice of Sale. Londer shall give Granter reasonable notice of the time and place of any public sale of the Personal Property or of the time after which any private sale or other intended disposition of the Personal Property is to be made. Reasonable notice shall mean notice given at least 10 days before the time of the sale or disposition.

Walver; Election of Remedies. A waiver by any party of a breach of a provision of this Mortgage shall not constitute a waiver of or prejudice the party's rights otherwise to demand strict compliance with that provision or any other provision. Election by Lender to pursue any remedy shall not exclude pursuit of any other remedy, and an election to make expenditures or take action to perform an obligation of Granter under this Mortgage after failure of Granter to perform shall not affect Lender's right to declare a default and exercise its remedies under this Mortgage.

Atterneys' Fees; Expenses.
