TOGETHER with all the improvements now or hereafter erected on the property, and all easements, rights, appurtenances, rents, royalties, mineral, oil and gas rights and profits, water, water rights, and water stock, and all fixtures now or hereafter attracted to the property covered by this Mortgage; and all of the foregoing, together with said property (or the leasehold estate if this Mortgage is on a leasthold) are herein referred to as the "Property".

Mortgagor covenants that Mortgagor is lawfully seized of the estate hereby conveyed and has the right to mortgage, grant, and convey the Property, and that Mortgagor will warrant and defend generally the title to the Property against all claims and domands, subject to any mortgages, declarations, easements, or restrictions listed in a schedule of exceptions to coverage in any title insurance policy insuring historiest in the Property.

COVENANTS. Mortgagor covenants and agrees as follows:

- 1. Payment of Principal and Interest, Mortgagor shall promptly pay when due the principal of and interest on the indebtodness incurred pursuant to the Agreement, together with any fees and charges provided in the Agreement.
- 2. Application of Paymonts, Unless applicable law provides otherwise, all payments received by Mortgagee under the Agreement and paragraph 1 hereof shall be applied by Mortgagee first in payment of amounts payable to Mortgagee by Mortgager under this Mortgage, then to interest, fees, and charges payable pursuant to the Agreement, then to the principal amounts outstanding under the Agreement.

If Mortgagor has paid any precomputed an ance charge, upon Mortgagor's payment of the entire outstanding principal balance and termination of the Equity Credit Line, Mortgagor shall be entitled to a refund of the uncarned portion of such prepaid finance charge in an amount not less than the amount that would be calculated by the actuarial method, provided that Mortgagor shall not be entitled to any refund of less than \$1.00. For the purposes of this paragraph the term "actuarial method" shall mean the method of allocating payments made on a debt between the outstanding balance of the obligation and the precomputed finance charge pursuant to which a payment is applied first to the accused precomputed finance charge and any remainder is subtracted from, or any deficiency is added to the outstanding balance of the obligation.

- 3. Churges; Liens, Mortgagor shall pay or cause to be paid all taxes, assessments, and other charges, fines, and impositions attributable to the Property that may attain a priority over this Mortgage, leasehold payments or ground rents, if any, and all payments due under any mortgage disclosed by the title insurance policy insuring Mortgagee's interest in the Property (the "First Mortgage"), if any, Upon Mortgagee's request, Mortgagor shall promptly furnish to Mortgageo receipts evidencing payments of amounts due under this paragraph. Mortgager shall promptly discharge any lien that has priority over this Mortgage, except the lien of the First Mortgage; provided, that Mortgagor shall not be required to discharge any such lien so long as Mortgagor shall agree in writing to the payment of the obligation secured by such lien in a manner acceptable to Mortgagee, or shall in good faith contest such lien by, or defend enforcement of such lien in, legal proceedings that operate to prevent the enforcement of the lien or forfeiture of the Property or my part thereof.
- 4. Hazard Insurance, Mortgagor shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage", and such other hazards as Mortgagee may require and in such amounts and for such periods as Mortgagee may require; provided, that Mortgagee shall not require that the amount of such records exceed that amount of coverage required to pay the total amount secured by this Mortgage, taking prior liens and co-insurance into account

The insurance carrier providing the in arance shall be chosen by Mortgagor and approved by Mortgages (which approval shall not be unreasonably withheld). All premiums on insurance policies shall be paid in a timely manner. All insurance policies and renevels thereof shall be in form acceptable to Mortgagee and shall include a standard mortgage clause in favor of and in form acceptable to Mortgagee Mor gagor shall promptly furnish to Mortgagee all renewal notices and an receipts for paid promiums. In the event of loss, Mortgagor shall give prompt notice to the insurance carrier and Mortgagee Mortgagee may make proof of oss if not made promptly by Mortgagor.

Unless Mortgagee and Mortgager otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damage. provided such restoration or repair is economically feasible and the security of this Mortgage is not thereby impaired. If such restoration or repair is not economically feasible or if the security of this Mortgage would be impaired, the insurance proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Mortgagor, If the Property is abandoned by Mortgagor or if Mortgagor fails to respond to Mortgageo within 30 days from the date notice is mailed by Mortgagee to Mortgager, that the insurance carrier offers to settle a claim for insurance benefits Mortgagee is authorized to collect and apply the insurance proceeds at Mortgagee's option either to restoration or repair of the Property or to the sums accured by this Mortgage.

Unless Mortgages and Mortgagor otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the payments due under the Agreement or change the uncount of such payments. If under paragraph 19 hereof, the Property is acquired by Mortgagee, all right, title, and interest of Mortgager in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to the sale or acquisition shall pass to Morigagee to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

- 5. Preservation and Maintenance of Property; Condominiums; Planned Unit Lenscholds: Developments, Mortgagor shall keep the Property in good repair and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any lease if this Mortgage is on a leasohold. If this Mortgage is on a unit in a condominium or a planned unit development, Mortgagor shall perform all of Mortgagor's obligations under the declaration or coverants creating or governing the condominium or planned unit development, the hylaws and regulations of the condominium or planned unit development, and constituent documents. If a condominium or planned unit development rider is executed by Mortgagor and recorded together with this Mortgago, the covenants and agreements of such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Mortgage as if the rider were a part hereof.
 - 6. Protection of Mortgagee's Security, If Mortgagor falls to perform the covenants and agreements contained in this Mortgage, or if any action or proceeding is commenced that materially affects Mortgageo's interest in the Property, including, but not limited to, any

proceeding by or on bohalf of a prior mortgagee, eminent domain, insolvency, code enforcement, or arrangements or proceedings involving a bankrupt or decedent, Mortgagee, at Mortgagee's option, upon notice to Mortgagor, may make such appearances, dishurse such sums and take such action as is necessary to protect Mortgageo's interest, including, but not limited to, dishursement of reasonable attorneys' fees and entry upon the Property to make repairs.

Any amounts disbursed by Mortgageo pursuant to this paragraph 6, with interest thereon, shall become additional indebtedness of Mortgagor secured by this Mortgage. Unless Mortgagor and Mortgagos agree to other terms of payment, such amounts shall be payable upon Mortgagee's domand and shall bear interest from the date of disbursement at the rate payable from time to time on outstanding principal under the Agreement. Nothing contained in this paragraph 6 shall require Mortgagee to incur any expense or take any action hereunder.

- 7. Inspection. Mortgagee may make or cause to be made reasonable entries upon and inspections of the Property, provided that Mortgagee shall give Mortgagor notice prior to any such inspection specifying reasonable cause therefor related to Mortgagee's interest in the Property.
- 8. Condemnation. The proceeds of any award or claim for damages. direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condomnation, are hereby assigned and shall be paid to Mortgagee. In the event of a total taking of the Property, the proceeds shall be applied to the sums secured by this Mortgage, with the excess, if any, paid to Mortgagor. In the event of partial taking of the Property, that fraction of the proceeds of the award with a numerator equal to the total of Loans and other amounts secured immediately before the taking, and a denominator equal to the value of the Property immediately before the taking, shall be applied to the sums secured by this Mortgage, and the excess paid to Mortgagor.
- If the Property is abandoned by Mortgagor, or if, after notice by Mortgagee to Mortgager that the condemner has offered to make an award of settle a claim for damages, Mortgagor falls to respond to Mortgagor within 30 days after the date such notice is malled, Mortgagee is authorized to folloct and apply the proceeds, at Mortgagee's option, either to restoration or repair of the property or to the sums secured by this Morigigu

- 9. Mortgagor Not Released. No extension of the time for payment or modification of my other term of the Agreement or this Mortgage granted by Mortgages to any successor in interest of the Mortgagor shall operate to relived in any manner, the limbility of the original Mortgagor and Mortgagor a successors in interest. Mortgagor shall not be required to commence proceedings a tainst such successor or refuse to extend time for payment or otherwise nicely by reason of any demand made by the original Mortgagor and Mortgrape's successors in interest.
- 10. Forebearance by Mortgaget Net a Waiver, Any forebearance by Mortgagee in exercising any vigitor remedy under the Agreement, herounder, or otherwise afforded by applicable law, shall not be a walver of or preclude the exercise of any such right or remedy. The procurement of insurance or the payment of taxes or other liens or charges by Mortgageo shall not be a waiver of Mortgageo's right to accelerate the maturity of the indebtedness secured by this Mortgage.
- 11. Successors and Assigns Bound; Joint and Several Liability: Captions. The covenants and agreements herein contained shall blind, and the rights herounder shall have to, the respective successors and assigns of Mortgages and Mortgager, subject to the provisions of paragraph 16 hereof. All coverants and agreements of Mortgagor shall be joint and several. The captions and headings of the paragraphs of this Mortgage are for convenience only and are not to be used to interpret or define the provisions hereof.
- 12. Legislation Affecting Mortgagee's Rights. If enactment or expiration of applicable laws has the effect of rendering any provision of the Agreement or this Mortgage unenforceable according to its terms. Mortgagee, at its option, may require immediate payment in full of all sums secured by this Mortgage and may invoke any remedies permitted by paragraph 19.
- 13. Notice. Except for any notice required under applicable law to be given in another manner, in any notice to Mortgagor provided for in this

Mortgage shall be given by mailing such a other by cott ied n all actioned to Mortgagor at the Property Address or at such other address as Mortgagor may designate by notice to Mortgagee as provided herein, and (b) any notice to Mortgagee shall be given by certified mail, return receipt requested; to Mortgagee's address stated herein or to such other address as Mortgagee may designate by notice to Mortgager as provided herein. Any notice provided for in this Mortgage shall be deemed to have been given to Mortgagor or Mortgagoe when given in the manner designated herein.

- 14. Governing Law; Severability. This Mortgage shall be governed by the laws of Illinois. In the event that any provision or clause of this Mortgage or the Agreement conflicts with applicable laws, such conflict shall not affect other provisions of this Mortgage or the Agreement which can be given effect without the conflicting provision, and to this end the provisions of this Mortgage and the Agreement are declared to be severable; provided that Mortgagee may exercise its termination option provided in paragraph 12 in the event of changes in law after the date of this Mortgage.
- 15. Mortgugor's Copy Mortgagor shall be furnished a conformed copy of the Agreement and I u is Mortgage at the time of execution or after recordation hereof.
- 16. Transfer of the Property Assumption. To the extent permitted by law, if all or any part of the Property or an interest therein, including without limitation any part of any implicial interest in any trust holding title to the Property, is sold or transferred by Mortgagor without Mortgagoo's prior written consent, Mortgr.gramay, at Mortgagoe's option, declare all the sums secured by this Moria go to be immediately due and payable
- 17. Revolving Credit Loan, This Mortgage is given to secure a revolving credit loan unless and until such loan is converted to an installment losn (as provided in the Agreement), and stall secure not only presently existing indebtedness under the Agreement but iso future advances, whether such advances are obligatory or to be made at the option of Mortgageo, or otherwise, as are made within 20 years from dischate hereof, to the same extent as if such future advances were made in the date of the execution of this Mortgage, although there may be no advarted made at the time of execution of this Mortgage and although there may be no indobtedness accured hereby outstanding at the time any advance

nal in any election dura d payable on or before 20 years after the date of this Mortgage. This Mortgage is given to and shall secure such installment loan.

19. Acceleration; Remedies. Upon Mort gagor's breach of any covenant or agreement of Mortgagor in this Mortgage, including the covenants to pay when due any sums secured by this Mortgage, or the occurrence of an Event of Default under the Agreement, which Events of Default are incorporated herein by this reference as though set forth in full herein. Mortgagee, at Mortgagee's option, may declare all of the sums secured by this Mortgage to be immediately due and payable without further demand, may terminate the availability of loans under the Agreement. and may forcelose this Mortgage by judicial proceeding, provided that Mortgagee shall notify Mortgagor at least 30 days before instituting any action leading to repossession or foreclosure texcept in the case of Mortgagor's abandonment of the Property or other extreme circumstances). Mortgagee shall be entitled to collect in such proceeding all expenses of foreclosure, including, but not limited to, reasonable attorneys' fees, and costs of documentary evidence, abstracts, and title reports.

All remedies provided in this Mortgage are distinct and cumulative to any other right or remedy under this Mortgage, the Agreement, or afforded by law or equity, and may be exercised concurrently, independently, or successively.

20. Assignment of Rents; Appointment of Receiver; Mortgagee in Possession. As additional security hereunder, Mortgagor hereby assigns to Mortgagee the rents of the Property, provided that Mortgagor shall, prior to acceleration under paragraph 19 hereof or abandonment of the Property, have the right to collect and retain such rents as they become due and payable.

Upon acceleration under paragraph 19 hereof or abandonment of the Property, and at any time prior to judicial sale, Mortgagee, in person, by agent, or by judicially appointed receiver, shall be entitled to enter upon. take possession of and manage the Property and to collect the rents of the Property including those past due. All rents collected by Mortgagee or the receiver shall be applied first to payment of the costs of management of the Property and collection of rents including, but not limited to receiver's fees, premiums on receiver's bonds, and reasonable atturneys' le's, and then to the sums secured by this Mortgage.
