CTHE COVENANTS, MORTGAGE): 1. Mortgagors shall (1) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or be destroyed; (2) keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien thereof; (3) pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof; and upon request exhibit satisfactory evidence of the discharge of such prior lien to the Mortgagee; (4) complete within a reasonable time any buildings now or at any time in process of erection upon said premises; (5) comply, with all requirements of law or municipal ordinances with respect to the premises, and the use thereof; (6) make no material alterations in said premises extept as required by law or municipal ordinance.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall pay special taxes, furnish to the Mortgagee duplicate receipts therefor. 5. At such time as the Mortgagors are not in default either under the terms of the note secured hereby or under the terms of this mortgage, the Mortgag is shall have such privilege of making prepayments on the principal of said note (in addition to the required payments) as may be provided in said note.

6. In case of default therein: M. gagee may, but need not, make any payment or perform any act hereinbefore required of Mortgagors in any form, and manner deemed expedient at d may, but need not, make full or partial payments of principal or interest on prior encumbrances, if any, and purchase, discharge, com a nise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premise, or contest any tax lien or other prior lien or title or any of the purposes herein authorized and all expenses paid or incurred in connection between the including attorneys fees, and any other moneys advanced by Mortgagee to protect the mortgaged premises and the lien hereof, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest, bereon at the highest rate now permitted by Illinois law.
