

Sec. 6321. Lien For Taxes.

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition therefol shall be a lien in favor of the United States upon all property, and rights to property, whether real or personal, belonging to such person.

Sec. 6322, Period Of Lien.

Unless another date is specifically fixed by law, the ifen imposed by section 6321 shall arise at the time the assessment is made and shall continue until the flability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Holders Of Security Interests, Mechanic's Lienors, And Judgment Lien Creditors.—The iten imposed by section 6321 shall not be valid as against eigh purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filled by the Secretary.

(n) Place For Filing Notice; Form.—

(1) Place For FIIIng.) The notice referred to in subsection (a) shall be filed.

(A) Under State Laws

(i) Real Property - in the case of real property, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated; and

(II) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental subdivision), as designated by the laws of such State, in which the property subject to the lien is situated of (SO).

(B) With Clerk DI District Court - In the office of the clerk of the United States district court for the judicial district in which the property subject to flen is situated, whonever the State has not by law designated one office which meets the requirements of subparagraph (A), or.

(C) With Recorder DI Deeds Of The District Of Columbia - in the office of the Recorder of Deeds of the District of Columbia - in the property subject to the flen is situated in the District of Columbia.

(a) Refilling Of Notice. — For purposes of this section -

(1) General Rule. — Unless notice of then is refilled in the manner prescribed in paragraph (2) during the required relilling period, such notice of iten shall be treated as filled on the date on which it is filled (in accordance with subsection (1)) after the expiration of such refilling period;

Sec. 6325. Release Of Lien Or Discharge Of Property

(a) Refense Of Liers. — Subject to such regulations as the Secretary may prescribe, the Secretary shell issue a certificate of release of any lien imposed with respect to any internal revenue tax not later than 30 days after the day sa which.

(1) Liability Selisfied or Unenforceable - The Secretary finds that the liability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has

become regally unenforceable; or

(k) Disclosure of Certain Returns and Return Information For Tax Administration Purposes.—

(2) Disclosure of amount of outstanding lien: - If a notice of ilen has been filled pursuant to section 6323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who turnishes satisfactory written avioance that he has a right in the property subject to such lien or intends to obtain a right in such property;
