

If any person liable to pay any tax neglects or refuses to pay the same after demand, the amount (including any interest, additional amount, addition to tax, or assessable penalty, together with any costs that may accrue in addition thereto) shall be a lien in favor of the United States upon all property and rights to property, whether real or personal, belonging to such person.

Sec. 6322. Period Of Lien.

Unless another date is specifically fixed by law, the lienimposed by section 6321 shall arise at the time the assessment is made and shall continue until the liability for the amount so assessed (or a judgment against the taxpayer arising out of such liability) is satisfied or becomes unenforceable by reason of lapse of time.

Sec. 6323. Validity and Priority Against Certain Persons.

(a) Purchaser's, Hoiders Of Security Interests, Mechanic's Lience and Judgment Lien Creditors. The form posed by section 8321 shall not be validated against any purchaser, holder of a security interest, mechanic's lienor, or judgment lien creditor until notice thereof which meets the requirements of subsection (f) has been filed by the Secretary.

(i) Place For Filling Notice; Form.—

(1) Place For Filling - The notice referred to in subrilon (a) shall be filed -

(A) Under State Laws

(i) Real Property - In the case of real property, in one office within the State (or the county, or other governmental; o ? subdivision), as designated by the laws of such State, in which the properly subject to the fien is situated; and

(II) Personal Property - In the case of personal property, whether tangible or intangible, in one office within the State (or the county, or other governmental Coubdivision), as designated by the laws of such State, which the property subject to the lien is situated;

(8) With Clerk Of District Court - in the office of the clerk of the United States district court for the judicial district in which the property subject to lien is situated, whenever the State has not by law designated one office which meets the requirements of subparagraph (A), or

(C) With Recorder Of Deeds Of The District Of Columbia - In the office of the Recorder of Deeds of the District of Columbia, if the property subject to the lien is situated in the District of Columbia

(B) Personal Property - in the case of personal property, which or tangible or intangible, at the residence of the taxpa, er at the time the notice of lien is filed.

For purposes of paragraph (2) (8), the residence of a corporation or partnership shall be deemed to be the place at which the principal executive of the business is located; and the residence of a lar aver whose residence is without the United States shall be deer led to be in the District of Columbia.

(3) Form - The orm and content of the notice referred to in subsection (a) shall be prescribed by the Secretary. Such notice an Co valid notwithstanding any 1/2 other provision of law regarding the form or content of a natics of lien.

(a) Reilling Of Notice. — For purposes of this

(1) General Rule. — Unless notice of tien is reflied in retiling period, such notice of lien shall be treated as filed on the date on which it is filled (in accordance with subsection (i)) after the expiration of such refiling period.

(2) Place For Filling. — A notice of tien refiled during the required refilling period shall be affective only $\mathcal{L}(z)$ (A) If a

(i) such notice of iten is reflied in the office in which the prior notice of lien was filed, and

(ii) in the case of real property, the fact of refilling is entered and recorded in an index to the extent regulaed by subsection (f) (4), and

(B) in any case in which, 90 days or more prior to the date of a refilling of notice of lien under subparagraph (A); the

Secretary received written information (in the manner prescribed in regulations issued by the Secretary) concerning a change in the texpayer's residence, if a notice of such flan is also filed in accordance with subsection (f) in the State in which such residence is located. 😅

(3) Required Refiling Period. — In the case of any notice of tien, the term "required refiling period" means -(A) the one-year period ending 30 days after the expiration of 5 years after the date of the assessment of the tax, and (B) the one-year period ending with the expiration of C years after the close of the preceding required refilling period for such notice of lien.

Sec. 6325. Release Of Lien Or Discharge Of Property.

(a) Release Of Lien. -Subject to such regulations as the Secretary may prescribe, the Secretary shall issue a certificate of release of any fian imposed with respect to any internal revenue tax not later than 30 days after the day on which -

(1) Liability Satisfied or Unenforceable - The Secretary finds that the ilability for the amount assessed, together with all interest in respect thereof, has been fully satisfied or has

become legally unenforceable; or

(2) Bond Accepted - There is furnished to the Secretary and acterited by him a bond that is conditioned upon the payment of amount assessed, together with all interest in respect thereof within the time prescribed by law (including any extension of Jurit time), and that is in accordance with such requirements 'ala" by to terms, conditions, and form of the bond and sureties threer, as may be specified by such regulations.

(k) Disclosure of Certain Returns and the manner prescribed in paragraph (2) during the required out Return Information For Tax Administration Purposes. —

> (2) Discipsure of amount of outstanding tien. - If a notice of lien has been filled pursuant to section 6323(f), the amount of the outstanding obligation secured by such lien may be disclosed to any person who lurnishes satisfactory written evidence that he has a right in the property subject to such tien or intenda in obtain a right in such property.
