That Section 1, Condition No. 6 of Village Section 1: Ordinance Number 87-2-2-1861 be and the same is hereby amended to read as follows:

That the air conditioner compressors shall not be · located in the required side or front yards fronting streets, with the exception of the location of the air conditioner units for townhouse #4 and townhouse #5.

Section 2: That Village Ordinance Number 87-2-Z-1861 be and the same is hereby amended to include the following under Section 1:

19. That the air conditioner compressor units along the Lincoln Avenue frontage of townhouse #4, and along the Gross Point Road frontage of townhouse #5, be heavily landscaped to shield the air conditioner units from view.

Section 3: That Village Ordinance No. 87-2-Z-1861 be and the same is hereby amended to include the following under Section 2:

- That the air conditioner compressor unit for 7. townhouse #4 may be located in the unit's front yard along Lincoln Avenue; and
- That the air conditioner compressor unit for townhouse #5 may be located in the unit's side 8. yard along Gross Point Road (the site's required front yard).

Section 4: That all other conditions of Village Ordinance Number 87-2-Z-1861 shall remain in full force and effect.
