AN ORDINANCE TO ANNEX CERTAIN TERRITORY TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

Section 2: The property commonly known as 1610 Elmdale Avenue and is legally described as:



Section 4: Every section and provision of this critinance shall be separable, and the invalidity of any portion of this ordinance shall not affect the validity of any other portion hereof.

Section 5: This ordinance shall take effect upon its passage, and approval according to law.
