ORDINANCE NO. 2860

AN OPDINANCE TO ANNEX CERTAIN TERRITORY TO THE VILLAGE OF GLENVIEW, COOK COUNTY, ILLINOIS

WHEREAS, there was filed with the Clerk of the Village of Glenview, a home rule municipality on February 28, 1988, a certain petition to annex to the said Village of Glenview, property hereing iter described; and

WHEFFAS, the President and Board of Trustees of the Village of Glenview have independently determined that said property described in the aforesaid petition is not within the corporate limits of any municipality, that it is contiguous to the present village limits of the Village of Glenview, and that all property owners, and electors have signed said petition as required by statute.

Section 1: The facts and statements contained in the preamble to this ordinance are found to be true and correct and are hereby adopted as part of this ordinance.
