PARTIAL RELEASE

KNOW ALL MEN BY THESE PRESENTS, that First Wisconsin National Bank of Milwaukee ("FWNBM") (herein referred to as "Mortgagee"), for and in consideration of the payment of the sum of Ten and No/100ths Dollars (\$10.00) and other valuable consideration, in hand paid, receipt of which is hereby acknowledged, does hereby REMISE, CONVEY, RELEASE AND QUIT CLAIM unto LaSalle National Bank, not individually, but solely as Trustee under Trust Agreement dated June 11, 1986 and known as Trust No. 111207 (herein referred to as "Mortgagor"), all right, title, interest, claim or demand whatsoever, which Mortgagee may have acquired in, through or by (a) a Mortgage made by Mortgagor dated October 31, 1986, and recorded on November 20, 1986, in the Office of the Cook County, Illinois Recorder of Deeds (the "Recorder") as Document No. 86552930, (b) a Mortgage dated February 19, 1987, and recorded on March 23, 1987 with the Recorder, as Document No. 87151519 (the "Mortgages"), as to a portion of the premises described in the Mortgages, said portion being described as follows:

It is expressly understood and agreed that this release is in no way to operate to discharge the lien of the Mortgages or the Assignment upon any other of the premises or property described therein but it is only to release the portion particularly described above and no others; and that the remaining or unleased portions of the premises in the Mortgages and the Assignment described are to remain as security for the payment of the indebtedness secured by the Mortgages and the Assignment and for the full performance of all the covenants, conditions and obligations contained in the Mortgages and the Assignment, the indebtedness secured thereby, and any other instruments given to secure the indebtedness secured thereby, and any other instrument given to secure the indebtedness secured by the Mortgages and the Assignment.

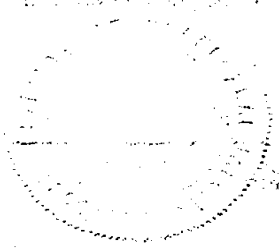

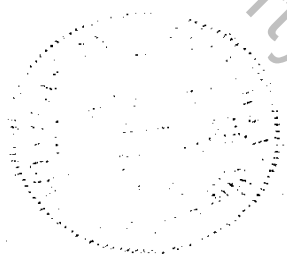
