AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS, COVENANTS AND BY-LAWS FOR

222 EAST CHESTNUT CONDOMINIUM ASSOCIATION

Amendment made this 5th day of April , 1988 by the 222 East Chestnut Condominium Association, an Illinois not-for-profit corporation (the "Association").

Recitals:

- A. On April 25, 1979, a certain Declaration of Condominium Ownership and of Eacements, Restrictions, Covenants and By-Laws for 222 East Chestnuc Condominium Association was recorded in the Office of the Recorder of Cook County, Illinois as document no. 24933769 (the "Declaration").
- B. Pursuant to the Declaration, Units 13A and 13B (the "Units") were created and made subject to the Declaration. The legal descriptions of said Units are attached hereto as Exhibits "A" and "B", respectively, and incorporated by reference herein.
- C. The Units are designated on the Plat of Survey attached as Exhibit A to the Declaration (the "Plat"). The Units have been assigned their respective percentage into ents in the common elements as specified in Exhibit B to the Occlaration.
- D. Pursuant to Sections 2.01(c) and 3.01 of the Declaration and Section 31 of the Illinois Condominium Property Act, Ill. Rev. Stat. (1985) chap. 30, para. 331 (the "Act"), units at 222 East Chestnut may be combined and subdivided with the approval of the Board of Managers of the Association (the "Board").
- E. Jerome Karp and Linda Karp (the "Karps") are the owners of the Units.
- F. The Karps having previously made application, pursuant to the Declaration and the Act, to the Board to combine and subsequently subdivide the Units, and a resolution approving the application having been passed by a majority of the Board and the combination and subdivision having been completed, and the President and Secretary of the Board having been authorized by the Board to execute this Amendment.

NOW THEREFORE, the Declaration is hereby amended as follows:

- 1. The page of the Plat which shows the Units is hereby superseded, in part, by the Plat of Survey attached hereto as Exhibit "C" and incorporated herein (the "Karp Plat"). In the event of any conflict between said Plats, the Karp Plat attached hereto as Exhibit "C" shall be deemed controlling. Any and all references to the Plat contained in the Declaration shall hereafter be deemed to include the Karp Plat.
- 2. The percentage interests in the common elements for the Units, as specified in Exhibit B to the Declaration, are hereby amended to be as follows:
