THIS INDENTURE, made MAY 20 19 88, between

NEPTALI MORALES AND CECILIA MORALES, HIS WIFE IN JOINT TENANCY herein referred to as "Mortgagors," and SECURITY PACIFIC FINANCIAL SERVICES INC A DELAWARE CORPORATION, herein referred to as TRUSTEE, witnesseth:
