a. Orleans loan. Deutsch and American National
as trustee under Trust Agreement dated August 20, 1986,
and known as Trust Number 069221-08 ("Orleans Trustee")
and Mortgage have entered into a Loan Agreement of
even date herewith wherein Bank agreed to make
available a \$1,200,000 non-revolving line of credit
("Orleans Loan"), which Orleans Loan is evidenced by a
Promissory Note ("Orleans Note") in like amount and of
even date herewith. The Orleans Loan is secured by a
Mortgage and Security Agreement, granting a lien on
property located at 1516 N. Orleans Street, Chicago,
Illinois, and by various other loan documents
identified in Exhibit B thereto (collectively, the
"Orleans Loan Documents").

1. Contemporaneously with the execution of this
Agreement, Deutsch, certain land trusts of which he is the sole
beneficiary, and Bank are entering into the following two

repayment of the Secured Indebtedness in addition to this
Mortgage, there have been executed and delivered to Mortgagee
certain other loan documents described in Exhibit B attached
hereto and made a part hereof. (The Note, this Mortgage, the
Loan Agreement and all other loan documents described in such
Exhibit B, whether now or hereafter existing, as may be amended,
modified or supplemented from time to time, are collectively
referred to as the "Loan Documents").

B. Loan. Mortgagee, its beneficiary, Owen Deutsch
("Beneficiary" or "Deutsch"), (Mortgagor and Beneficiary are
sometimes collectively referred to herein as "Borrower") and
Mortgagee have entered into a certain Loan Agreement ("Loan
Agreement") and Borrower has delivered to Mortgagee a Promissory
Note ("Note"), both dated as of February 10, 1988, providing for
a loan to or for the benefit of Mortgagee (the "Loan"). The Loan
is payable on or before February 10, 1988* and is in the
principal amount of ONE MILLION DOLLARS (\$1,000,000.00).

A. Real Estate. The Mortgagor is the owner and holder

Estate") which Real Estate forms a portion of Premises (as

F. Secured Indebtedness. The terms "Secured Indebtedness" and "Indebtedness" shall include: the indebtedness evidenced by the Note, Loan and other liabilities, including the principal and interest and premiums, if any, and all extensions, modifications, substitutions or renewals, in whole or in part, any future advances, with interest, made by the Mortgagee to Mortgagee, Borrower or other Deutsch Obligors ("Future Advances"); and all sums due or owing under the Other Deutsch Loans or Other Deutsch Loan Documents; and all other sums which at any time may be due or owing or required to be paid as provided herein or in the Loan Agreement or Note and all other indebtedness of Mortgagee, Borrower or the Deutsch Obligors to Mortgagee whether now or hereafter existing, whether direct or indirect, absolute or contingent, or due or to become

E. Liabilities & Future Advances. The parties intend to secure (on a priority basis from the date of recording of this Mortgage) payment of the "Liabilities" under both the Erie Loan Agreement and Orleans Loan Agreement, including the advanced to the respective Borrower prior, on or after this date. At any time before this Mortgage's cancellation and release, the Erie and Orleans Loans and their respective Notes and Loan Agreements, including their terms of repayment, may from time to time be modified or amended in writing by the respective borrower and Mortgagee to include future advances for any purpose made by the Mortgagee, at its option, to or for the benefit of such borrower. Mortgagee consents and agrees that this Mortgage secures (on a priority basis from the date of recording of this Mortgage) any and all such future advances, whether the same are of the same or a different kind or quality as the original advances or whether the interest thereon as well as the principal and interest now evidenced by the Erie and Orleans Loans.

The Orleans and Erie Loans are collectively referred to herein as the "Other Deutsch Loans", and their respective Loan Documents are collectively referred to as the "Deutsch Obligors".

2. Lake Geneva Loan. Mortgagee has made a loan in the amount of \$580,000.00 to Deutsch and Bonnie Deutsch, his wife, for the purpose of acquiring real estate located in Lake Geneva, Wisconsin ("Lake Geneva Loan") which loan is secured by a mortgage on the Lake Geneva property and certain other loan documents executed in conjunction therewith (collectively, the "Lake Geneva Loan Documents") and is further secured by a Junior Mortgage and Assignment of Rents and Security Agreement on property located at 1750 Sedgwick, Chicago, Illinois (as the same has been amended by Modification dated as of February 10, 1988 and may hereafter be amended, extended or renewed, the "Sedgwick Mortgage").

b. Erie Loan Amendment. Deutsch, American National as Trustee under Trust Agreement dated December 28, 1984, and known as Trust Number 63214 have entered into an Amended and Restated Note and Loan Agreement, wherein the Mortgagee agreed to make a loan in the amount of \$3,600,000 ("Erie Loan"), which loan is evidenced by a Promissory Note in like amount and of even date ("Erie Note"). The Erie Loan is secured by a Mortgage and Security Agreement, (as amended, the "Erie Mortgage") granting a lien on the property located at 514-524 W. Erie, Chicago, Illinois, and by various other loan documents identified on Exhibit B thereto (collectively, "the Erie Loan Documents").

TOGETHER with all right, title, estate and interest of the mortgagor in and to the premises, property, improvements,

2. Maintenance, Repair, Restoration, Liens, Etc., The Mortgagor shall (a) promptly repair, restore or rebuild any building or improvement now or hereafter included within the Premises which may become damaged or be destroyed whether or not proceeds of insurance are available or sufficient for the purpose; (b) keep the premises in good condition and repair, without waste, and free from mechanic's, materialmen's or like liens or claims or other liens or claims for lien; (c) pay, when due, any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof and, upon

1. Payment of Indebtedness. The Mortgagor shall pay when due (a) the principal of and interest and premium, if any, on the indebtedness evidenced by the Note and (b) all other Secured Indebtedness at the times and in the manner provided in the Note, this Mortgage and the other Loan Documents. The Mortgagor shall duly and punctually perform and observe all of the terms, provisions, conditions, covenants and agreements as provided herein and in the Note and other Loan Documents. This Mortgage shall secure such payment, performance and observance.

THE MORTGAGOR COVENANTS AND AGREES AS FOLLOWS:

GENERAL AGREEMENTS

PROVIDED, NEVERTHELESS, that if the Mortgagor shall pay or cause to be paid when due the Secured Indebtedness and shall duly and timely perform and observe all of the terms, provisions, covenants and agreements to be performed and observed by the Mortgagor, and shall cause full performance by the Deutsch Obligors under the other Deutsch Loan Documents, then this Mortgage and the estate, right and interest of the Mortgagee in the Premises shall cease and become void and of no effect, otherwise to remain in full force and effect.

TO HAVE AND TO HOLD the Premises, with the appurtenances, and fixtures, unto the Mortgagee, its successors and assigns, forever, for the uses and purposes set forth together with all right to possession of the Premises upon the occurrence of any Event of Default. The Mortgagor hereby RELEASES AND WAIVES all rights under and by virtue of the homestead exemption laws of the state of Illinois.

10. TOGETHER with all awards and other compensation heretofore or hereafter made to the present and all subsequent owners of the Premises for any taking by eminent domain, either permanent or temporary, of all or any part of the Premises or any easement or appurtenance thereof, including severance and consequential damage and change in grade of streets, Awards and compensation are hereby assigned to the Mortgagee. Mortgagor designates the Mortgagee as its agent and directs and empowers the Mortgagee, at the option of the Mortgagee, on behalf of the Mortgagor, or the successors or assigns of the Mortgagor, to adjust or compromise the claim for any award and to collect and receive the proceeds, give proper receipts and acquittances, and, after deducting expenses of collection, to apply the net proceeds as a credit upon any portion, as selected by the Mortgagee, of the Secured Indebtedness, notwithstanding the fact that the amount owing may not then be due and payable or that the Secured Indebtedness is otherwise adequately secured, all subject to the provisions of Paragraph

If any law or court decree has the effect of (i) deducting from the value of the land for the purpose of taxation any lien thereon; (ii) imposing upon the Mortgagee the payment of the whole or any part of the Taxes or liens required to be paid by the Mortgagee; or (iii) changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or the interest of the Mortgagee in the premises, or the manner of collection of Taxes, so as to affect this Mortgage or the Secured Indebtedness or the Mortgagee; then, and in any such event, the Mortgagee, upon demand by the Mortgagee, shall pay such Taxes, or reimburse the Mortgagee on demand. If such payment or reimbursement by the Mortgagee is unlawful, then the Secured Indebtedness shall be due and payable after written demand by the Mortgagee to the Mortgagee.

4. Taxes. The Mortgagee shall pay when due and before any penalty attaches, all general and special taxes, assessments, water charges, sewer charges, and other fees, taxes, charges, and assessments of every kind and nature whatsoever (all generally called "Taxes"), whether or not assessed against the Mortgagee, if applicable to the premises or any interest therein, or the Secured Indebtedness, or any obligation or agreement secured hereby. The Mortgagee shall, upon written request, furnish to the Mortgagee duplicate receipts. The Mortgagee shall pay in full under protest in the manner provided by statute, any Taxes which the Mortgagee may desire to contest. If deferment of payment of any such Taxes is required to conduct any contest or review, the Mortgagee shall deposit with the Mortgagee the full amount thereof, together with an amount equal to the estimated interest and penalties thereon during the period of contest, and in any event, shall pay such Taxes, notwithstanding such contest, if in the opinion of the Mortgagee the premises shall be in jeopardy or in danger of being forfeited or foreclosed. If the Mortgagee shall not pay the Taxes when required, the Mortgagee may do so and may apply such deposit for the purpose.

3. Other Liens. Except as otherwise expressly permitted herein, the Mortgagee shall not create or suffer or permit any mortgage, lien, charge or encumbrance to attach to the premises, whether such lien or encumbrance is inferior or superior to the lien of this Mortgage, excepting only the lien of real estate taxes and assessments not due or delinquent and those other encumbrances listed on Exhibit C ("Permitted Encumbrances").

Nothing in this Paragraph shall require the Mortgagor to pay any income, franchise or excise tax imposed upon the Mortgagor, excepting only such which may be levied against such income expressly as and for a specific substitute for Taxes pertaining to the Premises, and then only in an amount computed as if the Mortgage derived no income from any source other than its interest hereunder.

Mortgagee is hereby authorized to make or advance, in the place and stead of Mortgagor, any payment relating to any apparent or threatened adverse title, lien, statement of lien, encumbrance, claim, charge, or payment otherwise relating to any other purpose herein authorized, whenever, in its judgment and discretion, such advance seems necessary or desirable to protect the full security intended to be created by this Mortgage. In connection with any such advance, Mortgagee is further authorized, at its option, to obtain a continuation report of title or title insurance policy prepared by a title insurance company of Mortgagee's choosing. All such advances and indebtedness authorized by this Paragraph shall constitute additional secured indebtedness and shall be repayable by Mortgagor upon demand with interest.

5. Insurance Coverage. The Mortgagor will insure and keep fully insured all of the buildings and improvements now or hereafter included within the Premises and each and every part and parcel thereof, against such perils and hazards as the Mortgagee may from time to time require, and in any event including:

(a) Insurance against loss by fire, risks covered by the so-called extended coverage endorsement, and other risks as the Mortgagee may reasonably require, in amounts equal to the full replacement value of the Premises. During construction of the ERIE Improvements (as defined in the Loan Agreement) on the Premises, the insurance policies shall be in Builder's Risk form;

(b) Comprehensive public liability against death, bodily injury and property damage with such limits as the Mortgagee may require;

(c) Steam boiler, machinery and other insurance of the types and in amounts as the Mortgagee may require but in any event not less than customarily carried by persons owning or operating like properties;

(d) Insurance against loss or damage by flood or mud slide, if the Premises are now, or at any time while the Secured Indebtedness remains outstanding shall be, situated in an area which an appropriate governmental authority designates as a flood or mud slide hazard area or the like, in such amount as the Mortgagee may require, but no amount in excess of the minimum legal limit of coverage shall be so required;

(e) Worker's compensation insurance covering all persons engaged in any construction, alterations or improvements to the Premises, and insurance covering claims based on the owner's or employer's contingent liability not covered by the Mortgagor's public liability insurance, and

The amount of such deposits (generally called "Tax and Insurance Deposits") shall be based upon the Mortgagee's reasonable estimate as to the amount of Taxes and Insurance Deposits next to be payable. All Taxes and Insurance Deposits shall be held by the Mortgagee without any allowance for interest.

(i) One-twelfth (1/12) of the annual premiums on each policy of insurance upon the Premises; provided that in the case of the first such deposit, there shall be deposited in addition an amount which, when added to the aggregate amount of monthly sums next payable under this subparagraph (ii), will result in a sufficient reserve to pay the insurance premiums next becoming due one month prior to the date when such insurance premiums are, in fact, due and payable.

7. Deposits for Taxes and Insurance Premiums. In order to assure the payment of Taxes and Insurance premiums payable with respect to the Premises as and when due and payable:

The Mortgagee shall not take out separate insurance concurrent in form or contributing in the event of loss with that required hereunder unless the Mortgagee is included under a standard mortgage clause acceptable to the Mortgagee, with loss payable to Mortgagee. The Mortgagee shall immediately notify the Mortgagee whenever any separate insurance is taken out and shall promptly deliver to the Mortgagee any policies or certificates of such insurance.

6. Insurance Policies. All policies of insurance required by Paragraph 5 shall be in form, companies and amounts reasonably satisfactory to the Mortgagee. All policies of casualty insurance shall have attached thereto standard noncontributory mortgage clauses or endorsements in favor of and with loss payable to and in form satisfactory to the Mortgagee. The Mortgagee will deliver all policies, including additional and renewal policies to the Mortgagee and, in case of insurance policies about to expire, the Mortgagee will deliver renewal policies not less than thirty (30) days prior to the respective dates of expiration. All insurance policies shall contain a provision requiring at least thirty (30) days notice to the Mortgagee prior to any cancellation or modification of such policies. Mortgagee shall not permit any condition to exist on or with respect to the Premises which would wholly or partially invalidate any insurance.

(f) Rental or business interruption insurance in amounts sufficient to pay all amounts required by the Note and other Loan Documents by the Mortgagee for one year while the Premises may be damaged or destroyed.

(a) In case of loss covered by policies of insurance, the Mortgagee (or, after entry of decree of foreclosure, the purchaser at the foreclosure sale or decree creditor, as the case may be) and Mortgagor shall jointly settle and adjust any claim under such policies; provided, that Mortgagor may itself adjust losses aggregating not in excess of \$25,000.00 if such adjustment is carried out in a

8. Proceeds of insurance. The Mortgagor will give the Mortgagee prompt notice of any damage to or destruction of the Premises, and;

(e) Notwithstanding anything to the contrary, the Mortgagee, and its loan servicing agent, or their successors and assigns, shall not be liable for any failure to apply to the payment of Taxes and insurance premiums any amounts deposited as Tax and insurance deposits unless the Mortgagee, while no Event of Default has occurred and is continuing hereunder, shall have requested the Mortgagee in writing to make application of such deposits on hand to the payment of the particular Taxes or insurance premiums, accompanied by the bills therefor. Neither the Mortgagee nor its loan servicing agent shall be liable for any act or omission taken in good faith or pursuant to the instructions of any party.

(d) Upon the occurrence of an Event of Default, the Mortgagee may, at its option, apply any Tax and insurance deposits on hand to any of the Secured Indebtedness, in such order and manner as the Mortgagee may elect. When the Secured Indebtedness has been fully paid, then any remaining Tax and insurance deposits shall be paid to the Mortgagee. All Tax and insurance deposits are hereby pledged as additional security for the Secured Indebtedness, and shall be held by the Mortgagee to be irrevocably applied for the purposes as herein provided, and shall not be subject to the direction or control of the Mortgagee.

(c) The Mortgagee will, out of the Tax and insurance deposits, upon the presentation to the Mortgagee by the Mortgagor of the bills, pay the insurance premiums and taxes or will, upon the presentation of receipted bills, reimburse the Mortgagee for such payments made by the Mortgagee. If the total Tax and insurance deposits on hand shall not be sufficient to pay all of the Taxes and insurance premiums when they shall become due, then the Mortgagee shall pay to the Mortgagee on demand any amount necessary to make up the deficiency. If the total of such deposits exceeds the amount required to pay the Taxes and insurance premiums, such excess shall be credited on subsequent payments to be made for such deposits.

9. Disbursement of Insurance Proceeds. In the event the Mortgagee is entitled to reimbursement out of insurance proceeds held by the Mortgagee, such proceeds shall be disbursed from time to time upon the Mortgagee being furnished with (i) evidence satisfactory to it of the estimated cost of completion of the restoration, repair, replacement and rebuilding (or assurances satisfactory to the Mortgagee that such funds are available) sufficient in addition to the proceeds of insurance, to complete the proposed restoration, repair, replacement and rebuilding (iii) such architect's certificates, waivers of lien, contractor's sworn statements, title insurance endorsements, plats of survey and such other evidences of cost, payment and performance as the Mortgagee may reasonably require and approve. The Mortgagee may, in any event, require that all plans and specifications for such restoration, repair, replacement and rebuilding be approved by the Mortgagee prior to commencement of work. No payment made prior to the final completion of the restoration, repair, replacement and rebuilding shall exceed ninety percent (90%) of the value of the work performed from time to time. Funds other than proceeds of insurance shall be disbursed prior to disbursement of such proceeds. At all times the undisbursed balance of such proceeds remaining in the hands of the Mortgagee, together with funds deposited for that purpose or irrevocably committed to the satisfaction of the Mortgagee by

(d) If proceeds of insurance, if any, shall be made available to the Mortgagee for the restoring, repairing, replacing or rebuilding of the premises, the Mortgagee hereby covenants to restore, repair, replace or rebuild the same, to be of at least equal value, and of substantially the same character as prior to the insured casualty. Such work is to comply with plans and specifications approved by the Mortgagee.

(c) Except as provided in Subsection (b) of this Paragraph, the Mortgagee may apply the proceeds of insurance consequent upon any insured casualty to the Secured Indebtedness, in such order or manner as the Mortgagee may elect. Such application of proceeds shall not be considered a voluntary prepayment of the loan which would require the payment of any prepayment premium or penalty.

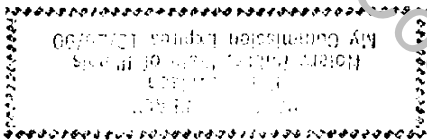
