## ORDINANCE NO. 88-9

### AN ORDINANCE ESTABLISHING CHARGES AND RATES FOR THE USE AND SERVICE OF THE COMBINED WATERWORKS AND SEWERAGE SYSTEM OF THE VILLAGE OF BROADVIEW, COOK COUNTY, ILLINOIS

BE IT ORDAINED by the President and Board of Trustees of the Village of Broadview, County of Cook and State of Illinois, that:

#### SECTION 1. GENERAL:

That on May 2, 1988, the President and Board of Trustees of the Village of Broadview adopted Ordinance No. 88-5 which provided for the combination of the existing waterworks system and the existing sewerage system of the Village of Broadview, Cook County, Illinois, into a combined waterworks and sewerage system and providing for their operation as a single utility. That on May 2, 1988, the President and Board of Trustees of the Village of Broadview adopted Ordinance No. 88-6, which provided for the issue of waterworks and sewerage bonds for defraying the cost of improving the combined waterworks and sewerage system of the Village. That it is necessary that the Village charge the inhabitants thereof for the use and service supplied by said sewerage system and that it is necessary to establish a sanitary sewer users fee. That a portion of the proceeds of the bond issue shall be reserved and utilized for the operation, maintenance, rehabilitation or reconstruction of the sanitary sewer system of the Village of Broadview.

#### SECTION II. RATES:

The following sanitary sewer usage fee schedule is hereby established.

- A. All residential, business and industrial users shall be charged a sanitary sewer usage fee of \$.15 per each 100 cubic feet of water. A minimum charge of \$.50 per quarter or every three (3) months shall be paid by each and every user of the sanitary sewer system.

## SECTION III. BILLING PROCEDURES, DISPOSITION OF FUNDS, NON-PAYMENT, AND NOTICE OF DELINQUENCY:

- A. Billing Procedures: Billing for sanitary sewer usage shall cover the same billing period, be issued coincident with and on the same form as billing for Village water service.
- B. Disposition of Funds: All revenues received in payment of sanitary sewer usage fee shall be deposited in the waterworks and sewerage fund of the Village.
- C. Non-Payment: Non-payment of sanitary sewer usage fees shall be addressed in the manner provided in Title 8, Sec. 8-4-6, as amended, of the Broadview Village Code, for non-payment of water charges.
- D. Notice of Delinquency: Whenever a sanitary sewer usage fee shall remain unpaid after twenty-five (25) days, the property concerned shall be subject to the procedures for delinquency and notice as set forth in Title 8, Sec. 8-4-6, as amended, of the Broadview Village Code.

## SECTION IV. EFFECTIVE DATE:

The sanitary sewer usage fees as established by this Ordinance shall be effective July 1, 1988. Such usage shall be billed quarterly with pro-rating as may be required for conformance to the water billing. This Ordinance shall be in full force and effect upon passage and publication as required by law.
