### **MORTGAGE**

GRANT OF MORTGAGE. Rents. The word "Rents" means all rents, revenues, income, issues, and profits from the Real Property and the Personal Property.

Possession and Use. Until in default, Grantor may remain in possession and control of and operate and manage the Property and collect the Rents from the Property.

Duty to Malintain. Grantor shall maintain the Property in first class condition and promptly perform all repairs and maintenance necessary to preserve its value.

Hazardous Substances. Grantor represents and warrants that the Property never has been, and never will be so long as this Morigage remains a lien on the Property, used for the generation, manufacture, storage, treatment, disposal, release or threatened release of any hazardous substance, as those terms are defined in the Comprehensive Environmental Response, Compensation and Liability Act of 1980, as amended, 42 U.S.C. Section 9501, at seq. (\*CERCLA\*\*), applicable state laws, or regulations adopted pursuant to either of the foregoing. Grantor agrees to indemnify and hold harmless Lender against any and all claims and losses resulting from a breach of this provision of the Mortgage. This obligation to indemnify shall survive the payment of the Indebtedness and satisfaction of this Mortgage.

Hulsance, Waste. Granter shall neither conduct or permit any nuisance nor commit or suffer any strip or waste on or to the Property or any portion thereof, including without limitation removal, or alienation by Granter of the right to remove, any timber, minerals (including oil and gas), or soil, or gravel or rock products.

Removal of Improvements. Grantor shall not demoish or remove any Improvements from the Real Property without the prior written consent of Lender. Lender shall consent if Grantor makes arrangements satisfactory to Lender to replace any Improvements which Grantor proposes to remove with Improvements of at least equal value.

Lender's Right to Enter. Lender and its agents and representatives may enter upon the Real Property at all reasonable times to attend to Lender's interests and to inspect the Property.

Compliance with Governmental Requirements. Grantor shall promptly comply with all laws, ordinances, and regulations of all governmental authorities applicable to the use or occupancy of the Property. Granter may contest in good faith any such law, ordinance, or regulation and withhold compliance during any proceeding, including appropriate appeals, so long as Grantor has notified Lender in writing prior to doing so and Lender's interess in the Property are not jeopardize. #### TAXES AND LIENS.

Payment. Grantor shall pay when due before they become delinquent of thems, special taxes, assessments, water charges and sewer service charges levied against or on account of the Property, and shall pay when due at others for work done on or for services rendered or material turnished to the Property. Grantor shall maintain the Property free of all liens having priority over or equal to the interest of Lender under this Mortgaga, except for the lien of taxes and assessments not due, except for the prior indebtedness liet med to below, and except as otherwise provided in the following paragraph.

Right To Contest. Evidence of Payment. Grantor shall upon demand furnish to Lender evidence of payment of the taxes or assiss ments and shall authorize the appropriate governmental official to deliver to Lender at any time a written statement of the taxes and assessments against the property.

Hotice of Construction. Grantor shall notify Lender at least 15 days before any work is commenced, any servicer are supplied to the Property, if any mechanics, materialmens, or other construction lien could be asserted on account of the work, services, or materials and the cost exceeds \$10,000.00. Grantor will on request furnish to Lender advance assurances satisfactory to Lender that Grantor can and will pay the cost of such improvements.

Grantor shall produce and maintain policies of fire insurance with standard extended coverage endorsements on a replacement basis for the full insurable value covering all improvements on the Real Property in an amount sufficient to avoid application of any coinsurance discretand with a standard mortgaged clause in favor of Lender. In no event shall the insurance be in an amount less than \$72,000.00. Policies shall be written by such insurance companies and in such form as may be reasonably acceptable to Lender. Grantor shall deliver to Lender configures of coverage from each insurer containing a stipulation that coverage will not be cancelled or diminished without a minimum of 30 days prior written notice to Lender.

Application of Proceeds. Grantor shall promptly notify Lender of any loss or damage to the Property. Lender may make proof of loss if Grantor talls to do so within 15 days of the casuality. Lender may, at its election, apply the proceeds to the reduction of the indebtedness, payment of any feet affecting the Property, or the restoration and repair of the Property. If Lender elects to apply the proceeds to restoration and repair, Grantor shall repair or replace the damaged or destroyed improvements in a manner satisfactory to Lender. Lender shall, upon satisfactory proof of such expenditure, pay or reimburse Grantor from the proceeds for the reasonable cost of repair or restoration if Grantor is not in default hereunder. Any proceeds which have not been disbursed within 180 days after their receipt and which Lender has not committed to the repair or restoration of the Property shall be used to pay any amounts owing to Lender under this Mortgage, then to prepay accrued interest, and then principal of the indebtedness. Compliance With Prior Indebtedness. During the period in which any prior Indebtedness described below is in effect, compliance with the insurance provisions contained in the instrument evidencing such prior Indebtedness shall constitute compliance with the insurance provisions under this Mortgage. to the extent compliance with the terms of this Mongage would constitute a duplication of insurance requirement. EXPENDITURES BY LENDER. If Grantor fails to comply with any provision of this Mongage, including any obligation to maintain prior indebtechass in good standing as required below, or if any action or proceeding is commenced that would affect Lender's interests in the Property, Lender may, at its option, on Grantor's behalf take the required action and any amount that it expends in so doing shall be added to the Indebtedness. Amounts so added shall be payable on demand with interest from the date of expenditure until paid at the Note rate. ## WARRANTY: DEFENSE OF TITLE

Title. Grantor warrants that it holds marketable title of record to the Property in fee simple, free and clear of all liens and encumbrances other than those set forth in the prior indebtedness section below or in any policy of title insurance issued in favor of, and accepted by, Lender in connection with this Mongage.

Defense of Title. Subject () the exception in the paragraph above, Grantor warrants and will forever defend the title to the Property against the lawful claims of all persons. In the event any action or proceeding is commenced that questions Grantor's title or the interest of Lender under this Mongage, Grantor shall defend the action, at its expense. Grantor may be the nominal party in such proceeding but Lender shall be entited to participate in the proceeding and to be represented in the proceeding by counsel of its own choice, and Grantor will deliver, or cause to be delivered, to Lender such instruments as may be requested by it from time to time to permit such participation.

Default. No Modification. Grantor shall not enter into any agreement with the hold is of any mortgage, deed of trust, or other security agreement which has priority over this Mortgage by which that agreement is modified, americal, catended, or renewed without the prior written consent of Lender. Grantor shall neither request nor accept any future advances under a prior morigage for diol trust, or other security agreement without the prior written consent of Lender.

### CONDEMNATION.

Application of Net Proceeds. If all or any part of the Property is condemned, Lender may at its election require that all or any portion of the net proceeds of the award be applied to the Indebtedness. The net proceeds of the award shall mean throward after payment of all reasonable costs, expenses, and afformeys' fees necessarily paid or incurred by Grantor, or Lender in connection with the condumnation.

Proceedings. If any proceedings in condemnation are filed, Grantor shall promptly notify Lender is writing and Grantor shall promptly take such steps as may be necessary to defend the action and obtain the award. FULL PERFORMANCE. Compilance Default. Failure to comply with any other term, obligation, covenant or condition contained in this Mortgage, the Note or in any of the Related Documents. If such a failure is curable and if Grantor has not been given a notice of a breach of the same provision of this Mortgage within the preceding 12 months, it may be cured (and no event of default will have occurred) if Grantor, after receiving written notice from Lender demanding cure of such failure: (a) cures the failure within 15 days; or (b) if the cure requires more than 15 days, immediately initiates steps sufficient to cure the failure and thereafter continues and completes all reasonable and necessary steps sufficient to produce compliance as soon as reasonably practical.

Breaches. Any warranty, representation or statement made or furnished to Lender by or on behalf of Grantor under this Mortgage, the Note or the Related Documents is, or at the time made or furnished was, false in any material respect.

Insolvency. The inscivery of Grantor, appointment of a receiver for any part of Grantor's property, any assignment for the benefit of creditors, the commencement of any prorouding under any bankruptcy or insolvency laws by or against Grantor, or the dissolution or termination of Grantor's existence as a going business (if Grantor is a business). Except to the extent prohibited by federal law or Illinois law, the death of Grantor (if Grantor is an individual) also shall constitute an event of default under this Mortgage.

Foreclosure, etc. Commencement of loreclosure, whether by judicial proceeding, self-help, repossession or any other method, by any credion of Grantor against any of the Property, how any this subsection shall not apply in the event of a good faith dispute by Grantor as to the validity or reasonableness of the claim which is the basis of the foreclosure, provided that Grantor gives Lender written notice of such claim and furnishes reserves or a surely bond for the claim satisfactory to Lender.

Leasehold Default. If the interest of Grantor in the Property is a leasehold interest, any default by Grantor under the terms of the lease, or any other event (whether or not the fault of Grantor) that result in the termination of Grantor's leasehold rights.

Breach of Other Agreement. Any breach by Grantor under the terms of any other agreement between Grantor and Lender that is not remedied within any grace period provided therein, including without limitation any agreement concerning any indebtedness or other obligation of Grantor to Lender, whether existing now or later.

Events Affecting Guarantors. Any of the preceding events one with respect to any guarantor of any of the indebtedness or such guarantor des or becomes incompetent, unless the obligations arising under the guarantor's estate in a manner satisfactory to Lender.

Insecurity. If Lender reasonably deems itself insecure.

Prior Indebtedness. Default of Grantor under any prior obligation or instrumeral securing any prior obligation, or commencement of any suit or other action to foreclose any prior lien on the Property.

RIGHTS AND REMEDIES ON DEFAULT. Upon the occurrence of any event of default of ust any time thereafter, Lender may exercise any one or more of the following rights and remedies, in addition to any other rights or remedies provided by time.

Accelerate Indebtedness. Lender shall have the right at its option without notice to Grantr to deduce the entire Indebtedness immediately due and payable, including any prepayment penalty which Grantor would be required to pay.

UCC Remedies. With respect to all or any part of the Personal Property, Lender shall have all this rights and remedies of a secured party under the Illinois Uniform Commercial Code.

Collect flents. Lender shall have the right, without notice to Grantor, to take possession of the Property and collect the Rents, including amounts past due and unpaid, and apply the net proceeds, over and above Lender's costs, against the Indebtedners. In furtherance of this right, Lender may require any tenant or other user of the Property to make payments of rent or use less directly to Lender. If the Pour's are collected by Lender, then Grantor intervocably designates. Lender as Grantor's attorney in fact to endorse instruments received in payment their of in the name of Grantor and to negotiate the same and collect the proceeds. Payments by tenants or other users to Lender in response to Lender and shall satisfy the obligations for which the payments are made, whether or not any proper grounds for the demand existed. Lender may exercise its up to under this subparagraph either in person, by agent, or through a receiver.

Mortgages in Possession. Lender shall have the right to be placed as mortgages in possession or to have a receiver applicable to take possession of all or any part of the Property, with the power to protect and preserve the Property, to operate the Property preceding foreclosure or sale, and to collect the Rents from the Property and apply the proceeds, over and above the cost of the receivership, against the Indebtedness. The mortgages in possession or receiver may serve without bond if permitted by law. Lender's right to the appointment of a receiver shall exist whether or not the apparent value of the Property exceeds the Indebtedness by a substantial amount. Employment by Lender shall not disqually a person from serving as a receiver.

Judicial Foreclosure. Lender may obtain a judicial decree foreclosing Grantor's interest in all or any part of the Property.

Nonjudicial Sale. If permitted by applicable law, Lender may foreclose Grantor's interest in all or any part of the Personal Property by nonjudicial sale.

Deficiency Judgment. If permitted by applicable law, Lender may obtain a judgment for any deficiency remaining in the Indebtedness due to Lender after application of all amounts received from the exercise of the rights provided in this section.

Other Remedies. Lender shall have all other rights and remedies provided in this Mortgage or the Note or by law.

Sale of the Property. To the extent permitted by applicable law, Grantor hereby waives any and all right to have the property marshalled. In exercising its rights and remedies, Lender shall be tree to sell all or any part of the Property together or separately, in one sale or by separate sales. Notice of Sale. If Lender institutes any suit or action to enforce any of the terms of this Mortgage, Lender shall be entitled to recover such sum as the court may adjudge reasonable as attorneys' fees at trial and on any appeal. Whether or not any court action is involved, at reasonable expenses incurred by Lender that in Lender's opinion are necessary at any time for the protection of its interest or the enforcement of its rights shall become a part of the Indebtedness payable on demand and shall bear interest from the date of expenditure until repaid at the Note rate. Expenses covered by this paragraph include, without limitation, however subject to any limits under applicable law, Lender's attorney fees and legal expenses whether or not there is a lawsuit, including attorneys' fees for bankruptcy proceedings (including efforts to modify or vacate any automaticistary or injunction), appeals and any enticipated post-judgment collection services, the cost of searching records, obtaining the reports (including brechouse reports), surveyors' reports, and appraisal fees, and title insurance, to the extent permitted by applicable law.
