That said owner, or the agent, architect or superintendent of owner (a) cannot, upon reasonable diligence, be found in said County, or (b) do not reside in said County.

That said contractor is entitled to credits on account thereof as follows: TWO THOUSAND AND NO/100 (\$2,000.00)

leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of THREE THOUSAND SEVENTY AND NO/100 (\$3,370.00) Dollars, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due or to become due from the owner under said contract against said contractor and owner.
