

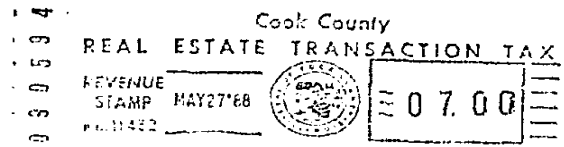
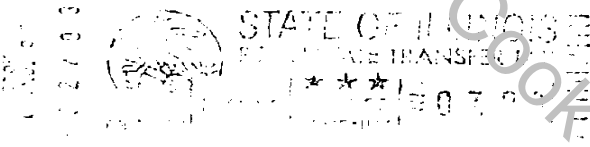
UNOFFICIAL COPY
