NOTICE OF LIEN

KNOW ALL MEN BY THESE PRESENTS, that 2020 Lincoln Park West Condominium Association, an Illinois not-for-profit corporation, has and claims a lien pursuant to Chapter 30, §309, of the Illinois Revised Statutes, against Parkway Bank & Trust Co., a/t/u/t/n 6794, and RJB I, Ltd., upon the property described herein below:

All of the North-South 12 foot vacated alley together with all that part of the East and West 12 foot vacated alley lying West of and adjoining the West line of Lot 4 in

Article V, Paragraph 5.10 of said Declaration provides for a creation of a lien for the monthly assessments or charges imposed pursuant thereto, together with interest, costs, and reasonable attorneys' fees necessary for collection.

That the balance of assessments, unpaid and owing pursuant to the aforesaid Declaration after allowing all credits, is the sum of \$1,029.49 through May 2, 1988. Each monthly assessment thereafter is in the sum of \$174.58 per month. Said assessments, together with interest, costs and reasonable attorney's fees constitute a lien on the aforesaid real estate.
