ASSIGNMENT OF RENTS

Parcel 1: Lot 1 in Block 1 in Gross Park Addition to Chicago, being a Subdivision of Blocks 39 and 50 in Ogden Jones and others Subdivision of Section 19, Township 40 North, Range 14 East of the Third Principal Meridian in Cook County, Illinois.

Parcel 2: Lot 2 in Block 1 in Gross Park Addition to Chicago of the South 33 Feet in Block 38, Section 19, Township 40 North, Range 14, East of the Third Principal Meridian in Cook County, Illinois.

and does authorize irrevocably the above mentioned Colonial Bank and Trust Company of Chicago

Colonial Bank and Trust Company of Chicago

or its agents, due or to become due, or that may hereafter be contracted, and also to the payment of all expenses and the care and management of said premises, including taxes and assessments, and the interest on encumbrances, if any, which may be in its judgement deemed proper and advisable.
