AMENDMENT TO TRUST DEED

- 2. Grantor and Beneficiary further agree that, from and after the date hereof Margaret McCaskill Visek shall be deered "Trustee" under the Trust Deed for all purposes.
- 3. Grantor and Beneficiary further agree that the Trust Deed is hereby amended to provide that Beneficiary (or any other lawful owner of the Indebtedness secured by the Trust Deed) may at any time hereafter substitute a new Trustee under the Trust Deed by recording a "Substitution of Trustee" in the office of the Recorder of Deeds for the county in which the Trust Deed was originally recorded.
