Borrower acknowledges that the Note allows for changes in the interest rate, and that the Lender may, prior to the expiration of the term of the Note, cancel future advances thereunder and/or require repayment of the outstanding balance under the Note. Increases in the interest rate may result in higher payments. Decreases in the interest rate may result in fower payments.

COVENANTS. Borrower and Lender covenant and agree as follows:

- 1. Payment of Principal and Interest. Borrower shall promptly pay, when due, without sctoff, or deduction, the principal of and interest on the debt evidenced by the Note, together with any late charges and other charges imposed under the Note.
- 2. Application of Payments. All payments received by Lender under the Note and this Mortgage shall be applied by Lender first in payment of amounts payable to Lender by Borrower under paragraphs 6 and 28 of this Mortgage, then to interest due on the Note, then to charges payable under the Agreement, and then to the principal of the Note
- 3. Prior Mortgages and Deeds of Trust; Charges; Liens. Borrower shall fully and timely perform all of Borrower's obligations under any mortgage, deed of trust or other security agreement with a lien which has or appears to have any priority over this Mortgage, including Borrower's covenants to make any payments when due. Borrower shall pay all taxes, assessments, charges, fines and impositions attributable to the Property which may attain priority over this Mortgage, and leasehold payments or ground tents, it any. Borrower shall promptly furnish to Lender all notices of amounts to be paid under this paragraph. The Borrower shall make these payments directly, and promptly furnish of a ender receipts evidencing the payments.

Borrower shall promphy discharge any hen which has priority over this Mortgage other than the prior mortgage described above, urbess Borrower; (a) agrees in writing to the payment of the obligation secured by the lien in a mainer acceptable to Lender; (b) contests, in good faith, the lien by or defends against enforcement of the lien in legal proceedings, which, in the Lender's opinion, operate to prevent the enforcement of the lien or forteiture of any part of the Property; or (c) secure from the holder of the lien an agreement satisfactory to Lender subordinating the lien to this Mortgage. If Lender determines that any part of the Property is subject to a lien which may attain priority over this Mortgage. Lender may give Borrower a notice identifying the lien. Borrower shall satisfy the lien, or take one or more of the actions set forth in the Mortgage, within 10 days of the giving of notice.

4. Hazard Insurance. Borrower shall keep the improvements now existing or hereafter elected on the Property insured against loss by fire, hazards included within the term "extended coverage" and such other hazards as Lender may require; provided that Lender shall not require that the amount of such coverage exceed that amount of coverage required to pay the sums secured by this Mortgage and all other mortgages and deeds of trust with respect to the Property, but, in no event, shall amounts be less than the amount necessary to satisfy the coinsurance requirements contained in the insurance policy. The insurance carrier providing the insurance shall be chosen by Borrower, subject to approval by Lender, which shall not be unreasonably withheld. All premiums on insurance policies shall be paid by Borrower when due

All insurance policies and renewals shall be in form acceptable of cender and shall include a standard mortgage clause in favor of and in form acceptable to Lender. Lender shall have the right to hold the policies and renewals subject to the terms of any mortgage, deed of trust or other security agreement with a lien which has, or appears to have, any priority over this Mortgage. If Lender requires, Borrower shall promptly furnish to Lender all renewal notices and all receipts of paid premiums. Borrower shall give prompt notice to me insurance carrier and to Lender of any loss or damage to the Property. Lender may make proof of loss if not mide promptly by Borrower. All poheies shall provide further that the Lender shall receive 10 days notice prior to cancellation.

Unless Lender and Borrower otherwise agree in writing, insurance proceeds shall be applied to restoration or repair of the Property damages, if the restoration or repair is economically feasible and Lender's security is not lessened. If the restoration or repair is not economically feasible or Lender's security would be lessened, the insurance proceeds shall be applied to the sums secured by this Mortgage, whether or not then due, with any excess paid to Borrower. If Borrower abandons the Property, or does not answer within 30 days a notice from Lender that the insurance carrier has offered to settle a claim, then Lender is irrevocably authorized to settle the claim and to collect and apply the insurance proceeds at the Lender's sole option either to restoration or repair of the Property or to the sums secured by this Mortgage. Lender may use the proceeds to repair or restore the Property or to pay sums secured by this Mortgage, whether or not then due. The 30 day period will begin when the Notice is given.

Unless Lender and Borrower otherwise agree in writing, any such application of proceeds to principal shall not extend or postpone the due date of the monthly installments referred to in the Mortgage or change the amount of such installments. If the Property is acquired by Lender, all right, title and interest of Borrower in and to any insurance policies and in and to the proceeds thereof resulting from damage to the Property prior to the sale or acquisition shall pass to I ender to the extent of the sums secured by this Mortgage immediately prior to such sale or acquisition.

- 5 Preservation and Maintenance of Property: Leaseholds, Condominiums; Planned Unit Developments. Borrower shall use, improve and maintain the Property in compliance with applicable laws, statutes, ordinances, requirements and regulations, shall keep the Property in good condition and repair including the repair or restoration of any improvements on the Property which may be damaged or destroyed, and shall not commit waste or permit impairment or deterioration of the Property and shall comply with the provisions of any lease it this Mortgage is on a leasehold. If this Mortgage is on a unit in a condominium or planned unit development, Borrower shall perform all of Borrower's obligations under the declaration or covenants creating or governing the condominium or planned unit development, the bylaws and regulations of the condominium or planned unit development, and constituent documents.
- 6. Protection of Lender's Rights in the Property. If Borrower fails to perform the covenants and agreements contained in this Mortgage or in the additional Credit Documents, or there is a legal proceeding that may effect Lender's rights in the Property (such as a proceeding in bankruptcy, probate, for condemnation, or to enforce laws or regulations), then Lender may do and pay for whatever is necessary to protect the value of the Property and Lender's rights in the Property. Lender's actions may include paying any sums secured by a hen which has priority over this Mortgage, appearing in court, paying reasonable attorney's lees and entering on the Property to make repairs. Although Lender may take action under this paragraph, Lender does not have to do so,

Any amounts disbursed by Lender under this paragraph shall become additional debt of Borrower secured by this Mortgage. Caless Borrower and Lender agree to other terms of payment, these amounts shall bear interest from the date of dishargment at the Note rate and shall be payable, with interest, upon notice from Lender to Borrower requesting pay ocut

- 7. Inspection. Lender of 3's agent may make reasonable entries upon and inspections of the Property. Lender shall give Borrower notice at the time of, or prior to, an inspection, specifying reasonable cause for the inspection.
- 8. Condemnation. The proceeds of any award or claim for damages, direct or consequential, in connection with any condemnation or other taking of the Property, or part thereof, or for conveyance in lieu of condemnation. are hereby assigned and shall be paid to Lander, subject to the terms of any mortgage, deed of trust or other security agreement with a lieu which has priority over this Mortgage. Borrower agrees to execute such further documents C as may be required by the condemnation authority to effectuate this paragraph. Lender is hereby irrevocably authorized to apply or release such moneys received or make settlement for such moneys in the same manner and with the same effect as provided in this Mortgage for disposition or settlement of proceeds of Hazard Insurance. No settlement for condemnation damages shalf be made without Lender's prior written approval
- Borrower Not Released; Forebearance by Lender Not a Waiver. Extension of the time for payment. acceptance by Lender of payments other than according to the terms of the Note, modification in payment terms of the sums secured by this Mortgage granted by Lender to any successor in interest of Borrower shall not operate to release the liability of the original Borrower. Borrower's successors in interest or any guarantor or surely thereof. Lender shall not be required to commence proceedings against any successor in interest or refuse to extend time for payment or otherwise modify payment terms of the sums secured by this Morigage, by reason of any demand made by the original Borrower or Borrower's successors in interest. Any forebearance by Lender in exercising any right or remedy shall not be a waiver of or preclude the exercise of any right or readly. A waiver as to one event shall not be construed as continuing or as a waiver as to any other event.
- 10. Successors and Assigns Bound: Joint and Several Liability; Co-Signers. The covenants and agreements of this Mortgage shall bind and benefit the successors and assigns of Lender and Borrower, subject to the provisions of paragraph 18. Borrower's covenants and agreements shall be joint and several. Any Borroy er who co-signs this Mortgage but does not execute the Note: (a) is co-signing this Mortgage only to mortgage, gran and convey that Borrower's interest in the Property under the terms of this Mortgage and to release homestead rights, if any; (b) is not personally obligated to pay the sums secured by this Mortgage; and (c) agrees that I end it and any other Borrower may agree to extend, modify, forbear or make any accommodations with regard to the terms of this Mortgage or the Note without that Borrower's consent and without releasing that Borrower or modifying this Mortgage as to that Borrower's interest in the Property.
- 11 Loan Charges. If the foan secured by this Mortgage is subject to a law which sets maximum foan charges. and that law is finally interpreted so that the interest or other loan charges collected or to be collected, in connection with the loan exceed the permitted limits, then: (a) any such loan charge shall be reduced by the amount necessary to reduce the charge to the permitted limit; and (b) any sums already collected from Borrower which exceeded permitted limits will be refunded to Borrower. Lender may choose to make this refund by reducing the principal owed under the Note or by making a direct payment to Borrower. It a refund reduces principal, the reduction will be treated as a partial prepayment without any prepayment charge.
- 12. Legislation Affecting Lender's Rights. If enactment or expiration of applicable laws has the effect of rendering any provision of the Note or this Mortgage unenforceable according to its terms. Lender, at its option. may require immediate payment in full of all sums secured by this Mortgage and may invoke any remedies permitted by paragraph 19

- 27. Riders To This Security Instrument. If one or more riders are executed by Borrower and recorded together with this Mortgage, the covenants and agreements of each such rider shall be incorporated into and shall amend and supplement the covenants and agreements of this Mortgage as if the rider(s) were a part of this Mortgage.
- 28. Expense of Latigation. In any suit to foreclose the ben of this Mortgage or entorce any other remedy of the Lender under this Mortgage, the Agreement, or the Note, there shall be allowed and included, as additional indebtedness in the judgment or decree, all expenditures and expenses which may be paid or incurred by or on behalf of Borrower for attorneys fees, appraisers lees, outlays for documentary and expert evidence, stenographers charges, publication costs, survey costs, and costs (which may be estimated as to items to be expended after entry of the decree) of procuring all abstracts of title, title searches and examinations, title insurance policies. - 18. Transfer of the Property. It borrower, or beneficiary of the Trust, if any, sells, conveys, assigns or transfers, or promises or contracts to sell, convey, assign or transfer, all or any part of the Property or any interest therein, including all or any part of the beneficial interest in the Trust, if any, or amends or terminates any ground leases affecting the Property, or it title to the Property, or any direct or indirect interest therein, is otherwise sold or transferred, voluntarily or involuntarily, including without limitation, sale or transfer in any proceeding for to recelosure or judicial sale of the Property or beneficial interest in the Trust, if any, in each case without Lender's prior written consent. Failure to pay such indebtedness within thirty (30) days after notice to Borrower of such acceleration shall constitute an Event of Default. Any use, or attempted use, by Borrower of the revolving line of credit evidenced by the Agreement and the Note after Borrower's sale, transfer, or promise to sell or transfer the Property or any direct or indirect interest therein, or amendment or termination of any ground leases affecting the Property, shall constitute a separate Event of Default.
- 19. Acceleration; Remedies (Including Freezing the Line). Upon the existence of an Event of Default, Lender may, at its sole option, terminate the line, declare all of the sums secured by this Mortgage to be immediately due and pavable without further demand, and invoke any remedies permitted by applicable law. (1) the nature of Borrower's breach or violation, (2) the action, it any, required of permitted to cure such breach or violation, (3) the applicable grace period, if any, during which such breach or violation must be cured, and (4) whether failure to cure such breach or violation within the specified grace period, if any, will result in acceleration of the sums secured by this Mortgage and the potential foreclosure of this Mortgage.

The notice shall further inform Borrower of the right, if any funder applicable law, to reinstate his reversing line of credit under this Mortgage after acceleration.

b. Events of Default. Set forth below is a list of events which, ipon the lapse of the applicable grace period. if any, will constitute Events of Default. (Applicable grace periods are set forth parenthetically after each event) The events are: (1) Borrower fails to pay when due any amounts due under the Credit Documents (ten (10) day grace period); (2) Borrower fails to keep the covenants and other promises made in paragraph 5 of the Agreement (no grace period); (3) Lender receives actual knowledge that Borrower omitted anderral information in Borrower's credit application or made any false or misleading statement on Borrower's credit application (no grace period); (4) Borrower dies or changes his or her marital status and transfers Borrower's interest in the Property to someone who either (i) is not also a signatory of all the Credit Documents (no grace period) or (ii) Susignatory of all the Credit Documents it such transfer, in Lender's reasonable judgment, materially impairs the security or the line of credit described in the Credit Documents (no grace period); (5) Borrower tiles for bankruptcy or Scale optcy proceedings are instituted against Borrower and not dismissed within sixty (60) calendar days, under any provision of any state or federal bankruptey law in effect at the time of filing (no grace period); (6) Borrower makes an assignment for the benefit of his or her creditors, becomes insolvent or becomes unable to meet his or her obligations renerally as they become due (no grace period); (7) Borrower further encumbers the Property, or suffers a hen, claim or lien or encumbrance against the Property (thirty (30) day grace period in which to remove the lien, claim of lien or encumbrance); (8) Borrower detaults or an action is filed alleging a default under any credit instrument or mortgage evidencing or securing an obligation of Borrower with priority in right of payment over the line of credit described in the Credit Documents or whose lien has, or appears to have, any priority over the lien hereof (no grace period). or any other creditor of Borrower attempts to (or actually does) seize or obtain a writ of attachment against the Property (no grace period); (9) Borrower fails to keep any other covenant contained in any of the Credit Documents not otherwise specified in this paragraph 17 (ten (10) day grace period, unless the failure is by its nature not carable, in which case no grace period or, if another grace period is specified in the Credit Documents, that grace period shall prevail); (10) Fractment or expiration of any applicable law which renders any provision of the Credit Documents unenforceable according to its terms, or (11) It, in Lender's good faith belief, the prospect of payment or performance is impaired
