

THIS INDENTURE, Made May 27, 19 88, between Danny A. Thompson and Trudith A. Thompson, his wife

herein referred to as "Mortgagors," and First National Bank of Mount Prospect, a National Banking Association residing in Mount Prospect, Illinois, (herein referred to as Trustee"), witnesseth:

THAT, WHEREAS the Mortgagors are justly indebted to the legal holder or holders of the Note hereinafter described (said legal holder or holders being herein referred to as Holders of the Note) in the principal sum of

SEVENTY NINE THOUSAND AND NO/100----- Dollars (\$79,000.00), evidenced by one certain Note of the Mortgagors of even date herewith, made payable to BEARER and delivered, in and by which said Note the Mortgagors promise to pay the said principal sum and interest on the balance of principal remaining from time to time unpaid at the rate of 10.00 % per annum prior to maturity as follows:

SEVENTY NINE THOUSAND AND NO/100----- Dollars (\$79,000.00), On ~~the~~ ~~DEMAND~~ ~~XX~~. All payments on account of the indebtedness evidenced by said Note shall be first applied to interest on the unpaid principal balance and the remainder to principal unless paid when due shall bear interest at the rate of 13.00 per cent per annum.

NOW, THEREFORE, the Mortgagors to secure the payment of the said principal sum of money and said interest in accordance with the terms, provisions and limitations of this Trust Deed, and the performance of the covenants and agreements herein contained, by the Mortgagors to be performed, and also in consideration of the sum of One Dollar in hand paid, the receipt whereof is hereby acknowledged, do by these presents CONVEY and WARRANT unto the Trustee, his successors and assigns, the following described Real Estate and all of their estate, right, title and interest therein, situate, lying and being in the Village of Palatine County of Cook and State of Illinois, to wit:

THIS IS A JUNIOR TRUST DEED ON THE SUBJECT PREMISES

Lot 38 in Block 22 in Winston Park North West Unit No. 2, being a subdivision in Section 13, Township 42 North, Range 10 East of the Third Principal Meridian, According to the Plat thereof, recorded in the Recorder's Office of Cook County, Illinois, as Document No. 17536792 and Re-recorded on June 30, 1959, as Document No. 17584144 in Cook County, Illinois. PIN#02-13-310-024 Property address: 344 Lytle, Palatine, IL

Document prepared by: Bradley K. Pierce, Asst. Vice President, First National Bank of Mount Prospect, which, with the property hereinafter described, is referred to herein as the "premises," Prospect, One First Bank Plaza, Mount Prospect, IL

TOGETHER with all buildings, improvements, tenements, easements, fixtures, and appurtenances thereto belonging, and all rents, issues, and profits thereof for so long and during all such times as Mortgagors may be entitled thereto (which are pledged primarily and on a parity with said real estate as security for the payment of the indebtedness secured hereby and not secondarily), and, without limiting the generality of the foregoing, all apparatus and equipment of every kind now or hereafter therein or thereon used to supply heat, gas, air conditioning, water, light, power, refrigeration (whether single units or centrally controlled), and ventilation, and all screens, window shades, storm doors and windows, awnings, door coverings, gas and electric stoves, stoves, boilers, sinks and water heaters. All of the foregoing are declared to be a part of said real estate whether physically attached thereto or not, and it is agreed that all similar apparatus, equipment or articles hereafter placed in the premises by the mortgagors or their successors or assigns shall be considered as constituting part of the real estate.

TO HAVE AND TO HOLD the premises unto the said Trustee, his successors and assigns, forever, for the purposes, and upon the uses and trusts herein set forth, free from all rights and benefits under and by virtue of the Homestead Exemption Laws of the State of Illinois, which said rights and benefits the Mortgagors do hereby expressly release and waive.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. Mortgagors (1) shall promptly repair, restore or rebuild any buildings or improvements now or hereafter on the premises which may become damaged or destroyed; (2) shall keep said premises in good condition and repair, without waste, and free from mechanic's or other liens or claims for lien not expressly subordinated to the lien hereof, except taxes and other governmental assessments not overdue; (3) shall pay when due any indebtedness which may be secured by a lien or charge on the premises superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such prior lien to Trustee or to holders of the Note; (4) shall complete within a reasonable time any building or buildings now or at any time in process of erection upon said premises; (5) shall comply with all requirements of law or municipal ordinance with respect to the premises and the use thereof; (6) shall make no material alterations in said premises except as required by law or municipal ordinance, without prior written consent of Trustee or holders of the Note being first had and obtained; and (7) shall not sell, transfer, assign or otherwise alienate (whether by land contract or otherwise), or encumber or suffer or permit any lien or encumbrance (whether or not junior and subordinated to the lien hereof) to exist upon the premises, or any part thereof, or any interest therein, without prior written consent of Trustee or holders of the Note being first had and obtained.

2. Mortgagors shall pay before any penalty attaches all general taxes, and shall pay special taxes, special assessments, water charges, sewer service charges, and other charges against the premises when due, and shall, upon written request, furnish to Trustee or to holders of the note duplicate receipts therefor. To prevent default hereunder Mortgagors shall pay in full under protest, in the manner provided by statute, any tax or assessment which Mortgagors may desire to contest.

3. Mortgagors shall keep all buildings and improvements now or hereafter situated on said premises insured against loss or damage by fire and such other hazards or contingencies as the holders of the note may require under policies providing payment by the insurance companies of moneys sufficient either to pay the cost of replacing or repairing the same or to pay in full the indebtedness secured hereby, all in companies satisfactory to the holders of the Note, under insurance policies payable, in case of loss or damage, to Trustee for the benefit of the holders of the Note, such rights to be evidenced by the standard mortgage clause to be attached to each policy, and shall deliver all policies, including additional and renewal policies, to holders of the Note, and in case of insurance about to expire, shall deliver renewal policies not less than ten days prior to the respective dates of expiration.

4. In case Mortgagors shall fail to perform any covenants herein contained, Trustee or the holders of the Note may, but need not, make any payment or perform any act hereinafter required of Mortgagors in any form and manner deemed expedient and may, but need not, make full or partial payments of principal or interest on prior encumbrances if any, and purchase, discharge, compromise or settle any tax lien or other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting said premises or contest any tax assessment. All moneys paid for any of the purposes herein authorized and all expenses paid or incurred in connection therewith, including reasonable attorneys' fees and any other moneys advanced by Trustee or the holders of the Note to protect the mortgaged premises and the lien hereof, plus reasonable compensation to Trustee for each matter concerning which action herein authorized may be taken, shall be so much additional indebtedness secured hereby and shall become immediately due and payable without notice and with interest thereon at the rate of seven per cent per annum. Inaction of Trustee or holders of the Note shall never be considered as a waiver of any right accruing to them on account of any default hereunder on the part of Mortgagors.

5. The Trustee or the holders of the Note hereby secured making any payment hereby authorized relating to taxes or assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the accuracy of such bill, statement or estimate or into the validity of any tax, assessment, sale, forfeiture, tax lien or title or claim thereof.

6. Mortgagors shall pay each item of indebtedness herein mentioned, both principal and interest, when due according to the terms hereof. At the option of the holders of the Note, and without notice to Mortgagors, all unpaid indebtedness secured by this Trust Deed shall, notwithstanding anything in the Note or in this Trust Deed to the contrary, become due and payable (a) in the case of default for ten days in making payment of any installment of principal or interest on the Note, or (b) when default shall occur and continue for thirty days in the performance of any other agreement of the Mortgagors herein contained.

10. No claim for the enforcement of the lien or any provision hereof shall be subject to any defense which would not be good and available to the party last named in an action at law upon the Note hereby secured.

11. Trustee or his holder of the Note shall have the right to inspect the premises at all reasonable times and access thereto shall be permitted for that purpose.

12. Trustee has no duty to examine the title, location, existence, or condition of the premises, nor shall Trustee be obliged to record this Trust Deed or to give any notice hereof, except as may be required by statute, and it may require indemnification satisfactory to it before recording any power hereof.

13. Trustee shall record this Trust Deed and the Lien thereof by proper instrument upon presentation of satisfactory evidence that all conditions secured by this Trust Deed have been fully paid, and Trustee may require and deliver a release hereof to and at the request of any person who shall, other than a Trustee named in the Trust Deed, give satisfactory evidence of payment of the Note, and such release shall be given by the Trustee to all persons named in the Trust Deed and to all the same parties and persons as named in the Trust Deed. No merger of remedies provided in this Trust Deed to be taken by the Trustee or the holder of the Note may be deemed to have occurred or happened. Any action or remedy provided in this Trust Deed to be taken by the Trustee or the holder of the Note may be taken in addition to or in lieu of any other action or remedy provided in this Trust Deed.

14. Trustee may record by instrument in writing in the office of the Recorder or Registrar of Titles in which this instrument shall have been recorded or filed, in case of the registration, location, or status of the above-named Trustee, then the Chicago Title and Trust Company, of Cook County, Illinois, shall be and it is hereby appointed, authorized and empowered for all acts performed hereunder.

15. The Trust Deed and all provisions hereof, shall extend to and be binding upon Mortgagee and all persons claiming under or through Mortgagee, and the word "Mortgagee" when used herein shall include the Note or the Trust Deed.

16. The Trustee individually, but jointly, with all other Trustees, shall have secured the Note or the Trust Deed.

17. The Trustee shall record this Trust Deed and the Lien thereof by proper instrument upon presentation of satisfactory evidence that all conditions secured by this Trust Deed have been fully paid, and Trustee may require and deliver a release hereof to and at the request of any person who shall, other than a Trustee named in the Trust Deed, give satisfactory evidence of payment of the Note, and such release shall be given by the Trustee to all persons named in the Trust Deed and to all the same parties and persons as named in the Trust Deed. No merger of remedies provided in this Trust Deed to be taken by the Trustee or the holder of the Note may be deemed to have occurred or happened. Any action or remedy provided in this Trust Deed to be taken by the Trustee or the holder of the Note may be taken in addition to or in lieu of any other action or remedy provided in this Trust Deed.
