#### ANNEXATION ORDINANCE FOR MCNEIL PROPERTY

WHEREAS, the clerk of Village of Lemont has received a petition for annexation in compliance with IL. Revised Statutes, Chapter 24, Section 7-1-8; and,

WHEREAS, the territory described in the petition is not within the corporate limits of any municipality but is contiguous to the Village of Lemont; and

WHEREAS, the land proposed to be annexed will continue to be serviced by the same Fire Protection District and Library District and will not include any highway under the jurisdiction of any township; and
