ORDINANCE NO. 857

AN ORDINANCE ANNEXING CERTAIN TERRITORY TO THE VILLAGE OF FLOSSMOOR, COOK COUNTY, ILLINOIS

(SIDERIUS - 3430 FLOSSMOOR ROAD)

WHEREAS, a written petition, signed by the legal owners of record of all land within the territory hereinafter described, has been filed with the Village Clerk of the Village of Flossmoor, Cook County, Illinois, requesting that said territory be annexed to the Village of Flossmoor; and

VALFREAS, there are no electors residing within the said territor; and

WHEREAS the said territory is not within the corporate limits of any municipality, but is contiguous to the Village of Flossmoor; and
