BORENSTEIN & CO., Contractor of Evanston, County of Cook, State of Illinois and LASALLE NATIONAL BANK & TRUST CO., as Trustee under Trust No. 107701 (hereinafter referred to as "owner"), of City of Chicago, County of Cook, State of Illinois and states:

That on January 25, 1988, the owner owned the land described on the attached Exhibit in the County of Cook, State of Illinois, and BEN A. BORENSTEIN & CO. was the owner's contractor for the improvement thereof.

That on January 29, 1988, said contractor made a subcontract with the claimant to Eurnish electrical fixtures, electrical wiring and other electrical work for the tenant improvements for and in said improvement, and that on March 13, 1988 the claimant completed thereunder all required by said contract to be done with a value of \$35,000 and a contract amount of \$62,367 including extras.

That said contractor is entitled to no credits on account, leaving due, unpaid and owing to the claimant, after allowing all credits, the sum of \$35,000, for which, with interest, the claimant claims a lien on said land and improvements and on the moneys or other considerations due from the owner under said contract against said contractor and owner.
