

RESCISION OF PLAT OF VACATION FILED IN ERROR

This document will serve to advise that the Plat of Vacation previously filed with the Recorder of Deeds of Cook County on May 24, 1988 as Document No. 88221004, covering the property legally described as follows:

THAT PART OF PUBLIC STREET KNOWN AS LARCH AVENUE IN THE NORTH EAST 1/4 OF THE SOUTH EAST 1/4 OF SECTION 30, TOWNSHIP 42 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, LYING WEST OF AND ADJACENT TO THE SOUTHWESTERLY LINE OF MILWAUKEE AVENUE, AS WIDENED, AND LYING EAST OF AND ADJACENT TO A LINE DRAWN NORTHERLY, AT RIGHT ANGLES TO THE SOUTH LINE OF SAID LARCH AVENUE, FROM THE NORTH EAST CORNER OF LOT 1 IN NORTHFIELD WOODS, BEING A SUBDIVISION OF PART OF LOT 3 IN SUPERIOR COURT PARTITION OF LOTS 6 AND 8 IN COUNTY CLERK'S DIVISION IN THE WEST 1/2 OF SECTION 29 AND ALSO LOTS 7 AND 8 IN COUNTY CLERK'S DIVISION OF SECTION 30, TOWNSHIP 42 NORTH, RANGE 12 EAST OF THE THIRD PRINCIPAL MERIDIAN, ACCORDING TO THE PLAT OF SAID NORTHFIELD WOODS RECORDED MAY 7, 1954 AS DOCUMENT 15900702 IN COOK COUNTY, ILLINOIS.

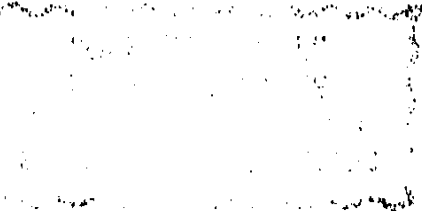
